## **CHAPTER 1**

### **INTRODUCTION AND FOREWORD**

Anyone familiar with the inhumane mullahs' regime and its main opposition People's Mojahedin Organization of Iran (PMOI) knows that from the very beginning of the Iranian people's resistance three decades ago to this day, there has been an all-out and relentless battle between the two sides in all arenas.

It is a huge war and confrontation with a regime that has been truly described as the most horrendous reactionary force in Iran's history that hijacked the Iranian people's reign for more than 35 years, and spared no effort in resorting to all crimes, deceptions and inhumane methods – especially against its main rival, the PMOI – to maintain its rule.

This inhumane regime, through its psychological warfare and demonization campaign, uses the most inhumane approaches and methods, such as misusing family affections to impose psychological torture on PMOI members and Ashraf and Liberty residents. These measures have been taken in a wide variety of dirty forms and methods. Of course, other dictators have also resorted to such despicable pretexts, but the mullahs' regime is an unprecedented example in the scope of taking such inhumane measures. In the meantime, there is a very small number of family members such as Mostafa Mohammadi that have been actually willing to sell their humane dignity and family affections to the mullahs' Intelligence (MOIS), and take part in this regime's filthy objectives and agenda's against the Iranian Resistance, especially its pioneers in Ashraf and Liberty, including imposing continuous psychological torture on their own loved ones.

In contrast to these rare cases, there are thousands of noble families and relatives in various cities across the country that have never succumbed to the relentless threats and bribes of the regime and the mullahs' intelligence services, refusing to become a puppet of the enemy's hideous shams against their loved ones in the PMOI.

Taking advantage of family relations is one of the most inhumane gimmicks used by the mullahs' regime against the PMOI in this regard, and it is primarily seeking to present perpetrators as the innocent and make the entire story very vague. Why? Because the PMOI have again and again proven their legitimacy in their more than three decade long struggle against the mullahs' regime. PMOI members that have sacrificed everything for their people - including all what is considered as their natural right , and because of such a sacrifice they have gained the strength to go on to the very end and continue in this comprehensive battle with the most horrific and reactionary force in Iran's history.

**My name is Somayeh Mohammadi. I am 34 years old and I am proud to be a member of the PMOI and a resident of Camp Liberty.**

For more than 10 years now, I have been a target of the psychological warfare and demonization campaign led by the mullahs' regime and its Ministry of Intelligence against the PMOI and their ranks and files under the guise of family relations.

The latest product of this filthy psychological warfare and demonization by the regime is a documentary ***"An unfinished film for My Daughter, Somayeh"*** produced by the regime's Ministry of Intelligence (MOIS).

In this fabricated and ridiculous "documentary", by resorting to misusing my family, and especially Mostafa Mohammadi who has for the past few years become an



active agent of the mullahs' MOIS, the regime has resorted to the most atrocious infamy that one can see only from the mullahs ruling Iran and their agents, and use me as a means for their dirty war; whereas I have very knowingly and freely chosen my path and devoted my life to an all-out struggle against the mullahs' regime, and to bring about freedom for my people and country.

Now, I want to shed light on and put an end to **the "story" behind the completely false, fabricated and "unfinished" scenario of the mullahs and Mostafa Mohammadi.**

The objective of this enlightenment is especially to be a hard-learned lesson for the youth of my country, and those who come across the so-called "documentaries, films and ..." for the first time, which are nothing but pretexts, scenarios and shams by the deceitful and inhumane regime under the guise of family relations and affections, and of course its shedding crocodile tears.

I want to show how the mullahs' regime, under the guise of family (mother, father, sister, ...), is seeking to hunt its prey to ultimately annihilate the PMOI that is the only struggling organization against that regime. To this end it goes the limits in its efforts to separate me and others like me from the PMOI, distance us from the epicenter of the Resistance, prevent us from perseverance and the struggle in the face of its evil being; and how this regime seeks to quash the fire of uprising and protests burning below the ashes—especially amongst women and Iran's younger and energetic generation – through such demonization and deceptions.



What the regime is concerned about has nothing to do with a father's affection to his child or so; rather it is mainly concerned about the threats to its very existence. Therefore, in order to secure its existence it would resort to all means such as crackdown, gallows, torture, humiliation , or by spreading addiction and prostitution, or even spreading fundamentalism, and eventually fully destruction of all human emotions.



I want to show how in this path a family, by “auctioning” their love, family relations and affections, sell their own child to the deathsmen of an entire nation, just because I had chosen my path for myself and because I have stood tall against the mullahs’ plots that aim to separate me from this struggle.

What the Iranian regime and its agents just fail to understand is the will and determination of a PMOI member, especially the pioneer women in the PMOI that have dedicated everything for the liberation of their people.

**The mullahs’ MOIS dispatched Mostafa Mohammadi along with some others as my family members to Iraq 24 times, and it spent a huge amount of money in a bid to separate me from the PMOI and Iranian Resistance. But it failed miserably in the end and returned with its tail between legs. Similarly – this time, let the fabricated stories and ridiculous documentaries of the MOIS and broadcasting them through nationwide TV channels across Iran lead to bigger embarrassments for the regime more than any other project, and leave them nothing but a major defeat and scandal after all the expenditures.**

My family very much agreed with me joining the National Liberation Army of Iran (NLA) stationed near the Iran-Iraq border and they supported me in this regard.

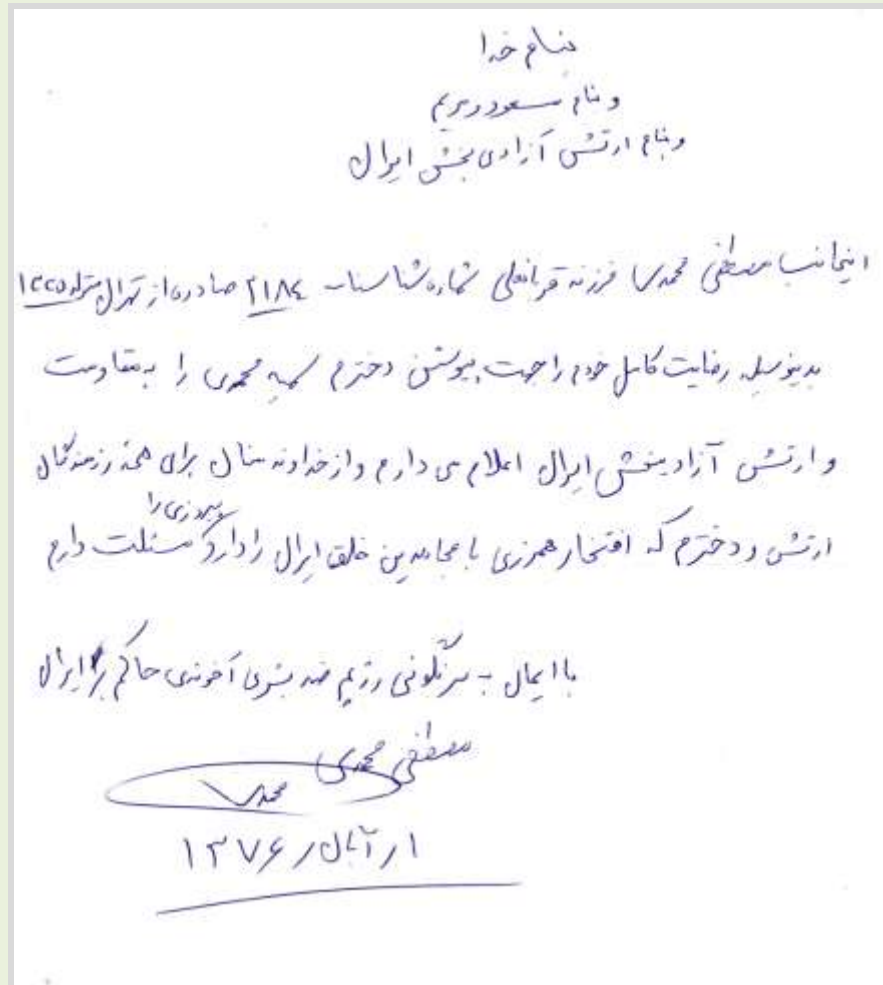
It was in February 1998 when I finally managed to join the NLA with my family assisting and providing the expenses.

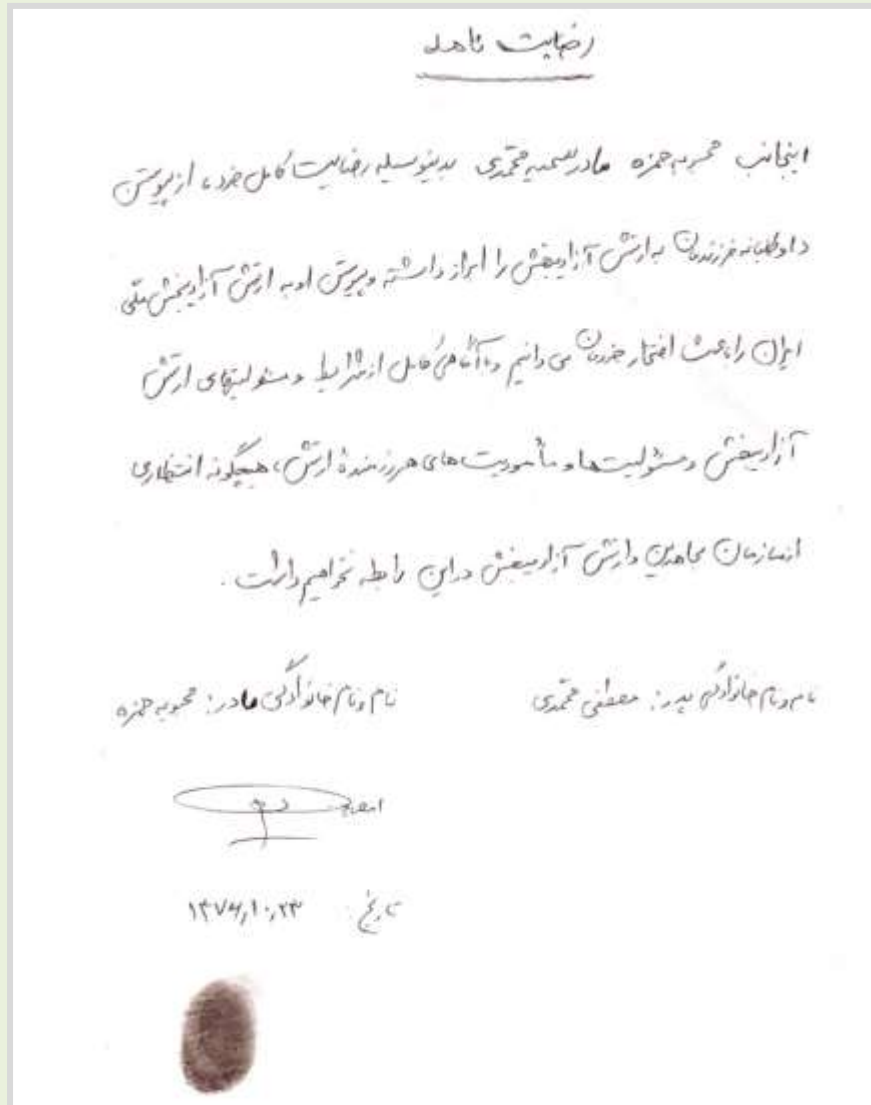

At the same time a number of my friends came to Camp Ashraf from the US and Canada, and we were in one section for a long time in Ashraf.

This included my PMOI colleagues Asieh Rakhshani and Saba Haft-Baradaran who were viciously murdered on 8 April 2011, gunned down in cold-blood by Iranian regime agents and its puppet Maliki government in Iraq.

Asieh Rakhshani was killed in direct gunfire by a colonel from Maliki's army while she was busy filming scenes of crimes being committed by Iraqi armed forces in their attack against Camp Ashraf.

This was a very difficult moment for her father, but for the bliss, fortune and freedom of millions of other “Saba”s, meaning the girls of my country and my beloved sisters in Iran that are these days being victimized by the regime's acid attacks, he chose not to succumb to the foul mullahs' regime and courageously turned down their offer, believing this would be preposterous submissiveness.

This is the culture and methods used by villains that take hostage human affections to make people waver. However, they all know that PMOI members have devoted their lives to a relentless struggle

### **CHAPTER 3**

## **11 YEARS OF PSYCHOLOGICAL WARFARE UNDER THE GUISE OF FAMILY RELATIONS**

My brother Mohammad also joined the National Liberation Army of Iran (NLA) in August 1998 six months after me.

In March 2003, meaning the very days before the US-led war against Iraq, my mother, father, brother and sister came to Iraq to see me and Mohammad. My brother and I went to Baghdad to meet them and we also went for a pilgrimage to Karbala. Then they came to Ashraf and stayed there for about a week as our guests, and I took them to visit all the sites in the camp.

They asked me and Mohammad to return back to Canada with them; however, during their stay, I underscored time and again my personal will to remain in Ashraf.

In those days, the prospect of a war and US attack on Iraq had become nearly definite and very imminent. Given the fact that conditions in Iraq were very dangerous, Mohammad and I asked them to leave Iraq and return to Canada. They returned to Canada at the PMOI's expense the day before the war began.

For some time after the US-Iraq war, meaning around November 2003, my father came to Iraq again to see me. In that trip he remained in Ashraf as our guest for a month. My higher-ups in the PMOI told me to choose whether to stay or leave, and on many occasions suggested and requested that I return with him to Canada. However, my decision was to stay and continue my struggle. The third time that my father visited Ashraf (December 2003), my mother and sister also joined him and they were with us for a week.

The fourth time (March 2004) my father and uncle came to Ashraf to see me and Mohammad.

In late summer of 2004, my brother no longer could tolerate the hardships of staying in Ashraf. My higher-ups immediately contacted my father in Canada and told him that Mohammad wanted to return to Canada, asking him to come to Ashraf with all the necessary documents and take him back.

Shortly Mostafa Mohammadi came to Iraq to resolve the work necessary for Mohammad's legal exit from Iraq. They were our guests in Ashraf for about three months. During this period the PMOI was very hospitable to him, and he participated in many gatherings, ceremonies and celebrations.

## Using US forces against PMOI organization

### “Soft Dissolution”

In the years following the war and occupation of Iraq (from 2003 to 2008), the MOIS (mullahs' intelligence) and IRGC-- especially the terrorist Quds Force-- infiltrated into the so-called TIPF facility that was established adjacent to Camp Ashraf to house the disassociated PMOI affiliates but it was used for the “dissolution” and “ Graceful Degradation” -- as described by the US forces -- of the PMOI and NLA. TIPF was thus turned into a nest of espionage and a site for the Iranian regime intelligence elements for espionage and recruiting hirelings.

After TIPF was closed down, various hotels in Baghdad were used for the same purpose.

The revelations below shed light on part of this conspiracy.

#### Letter of Colonel Leo McCloskey, JIATF Commander at Camp Ashraf

3 March 2012

Date: Sat, Mar 3, 2012

During the 4 years existence of the ARC a large number of the residents in the ARC requested to be repatriated to Iran with the assistance of the Red Cross. After repatriation we never heard from those individuals again with the exception of a woman by the name of Batul Soltani.

Batul was repatriated to Iran in January of 08 and by February of 08 she returned to Iraq with an Iranian passport and a story that she had escaped Iranian agents in Baghdad.

She then started protesting at the main entrance to Camp Ashraf indicating that her husband was being held in the camp against his will.

I interviewed her former husband several times and he had no desires to leave the camp. (It was my informed opinion that Batul was working for the Iranian Quds Force.)

The US believed that by having the Refugee Camp adjacent to Camp Ashraf is would encourage others to leave the organization through a process of "Graceful Degradation" which would eventually lead to the closure of Camp Ashraf. That desirable outcome did not occur....

Paris – 24 March 2012

*...Approximately 300 decided to go back to iran... i can tell you that the people of ashraf residents were there because they want to be there... and like in any other organization, some people do want to leave and these people were allowed to leave by the leadership and by the residents of ashraf... with the intent that this would serve as an example, if we could relocate these people to other places around the world, that would then say to the residents of ashraf you don't need to stay here anymore; you could go at any time and believing that this policy of graceful derogation would lead to the closure of camp ashraf...*

In this regard various TIFP officers were in various areas of Ashraf seeking to recruit traitors or defectors and persuade PMOI members to go to TIFP.

As mentioned earlier, due to the Iranian regime's influence in Iraq it didn't take long for TIFP to become a site where the mullahs' Ministry of Intelligence agents, including traitors and defectors, were commuting to and from and a place for pursuing their plots.

Mostafa Mohammadi came to Ashraf to take Mohammad in 2004 and stayed there. In those days I noticed changes in his attitude and approach.

### **Mostafa Mohammadi's relations with US forces trying to make me defect**

Mostafa Mohammadi met with the Americans that were in charge of Ashraf's protection at the time and had established TIPF. He requested them to place pressure on me to separate myself from the PMOI and leave Ashraf.

From then on a US colonel in charge of the TIPF by the name of Georges, along with an interpreter by the name of Paria, used to come to 'Hotel Iran' in Ashraf where we were staying every day, and in cooperation with Mostafa Mohammadi they tried to dissuade me from continuing my struggle and advise me to leave Ashraf and return to an ordinary life. They made many contradicting remarks against the PMOI and highlighted the "benefits" of returning to an ordinary life and ... They also said words in defense of the traitors in TIPF; in short, they attempted to make me regret ever choosing this path and stop me from continuing my struggle, while I had freely decided to go down this path as a grown and knowledgeable woman.

They also repeatedly explained the dire conditions in Iraq in an attempt – as they sought – to scare me; through various methods of intimidation or encouraging, they wanted me to depart Ashraf.

For this very reason I decided to go the hotel less to see them in order to have fewer interactions with them.

But each time under some excuse they used to call me to the location where Mostafa and Mohammad were stationed in Hotel Iran, and I had no choice to go because if I did not go, they would use it as a pretext for a smear campaign and lies against the PMOI, and they would say, "It is actually the organization that is not allowing Somayeh to go to the hotel to see her father and brother."

Therefore, each day Mostafa, Paria and Georges came to me with the intention to impel me by any means to defect from the PMOI and my struggle, make me go to the TIPF and wait for my work to be resolved!

In one of those days (2004) before Mostafa Mohammadi went to Canada, I was very upset and under tremendous strain from the joint pressures imposed by him and US forces running TIPF when they told me I had to write a letter to the Canadian Embassy and ask them to make the necessary arrangements.

At that time a lady from the Canadian consulate came to Ashraf and met with Mohammad and Mostafa Mohammadi. Their intention behind my writing a letter was for me to write that I am under pressure in the organization. They also quoted defected PMOI members that they had been tortured inside the organization. They wanted me to lie and portray a negative image of my organization, the PMOI, so they



would be able to use this letter for their own purposes in favor of the Iranian regime and its Ministry of Intelligence.

However, I did not give in and told them, "I am not writing any letters for anyone and will not do what you say. Neither am I a person to depart Ashraf."

They told me:

"Then just write for them to make the necessary arrangements for the future, and if you don't write this they will not allow Mohammad to leave either, and they will think that like you Mohammad is not willing to leave, and his work will take a long time and you will be forced to endure more such days."

At that time I was still unaware of the despicable nature of such plots by the Iranian regime and taking advantage of PMOI family members, and I could not understand exactly why they are placing me under so much pressure.

I wished that period would come to an end quickly and I would get rid of all those predicaments. To get rid of them and their pressures I wrote a letter to the Canadian Embassy.

However, not only their pressures and psychological tortures never decreased, but it actually escalated.

There I learned what a mistake I had made and that I should have not done so in order to get rid of those filthy pressures.

Their measure always reminded me of getting forced confessions in the mullahs' prisons. That is why I always detested Mostafa Mohammadi and others that played such a role. Each time that Mostafa Mohammadi and the team of American TIFP officers came to the hotel, they gave me gifts to lure me to their demands and become closer to them. They also tried to be kind, but I paid no attention to their words and efforts, and I was disgusted with all their games and plays aimed at separating me from my cause and beliefs.

Therefore, all my efforts were focused to finalize the preparations for Mohammad (who had defected by then) and for him to leave Ashraf as soon possible because Ashraf was only the place of devoted PMOI members.

Finally, in the fall of 2004 Mostafa Mohammadi left for Canada and Mohammad's case was resolved after three months.

One day before they took Mohammad, the American officers in charge of TIFP came again to try to derail me from my path, not knowing they could not and I would not let them undermine my freedom of choice, because I knew quite well that through their measures they were practically playing into the hands of the mullahs' regime and their notorious Ministry of Intelligence.

There they called my mother while it was obvious they had planned this in advance. They told me your mother wanted to talk with you and had asked them to arrange this phone call.

Subsequently in a call with my mother, her insistence on me to leave the PMOI made me wonder what was going on. Why are they all colluding with each other to make me leave the PMOI?

I told my mother in that phone call: "... you sent me here yourself, and now you want me to return? I am not immature and ignorant to let you decide for me about my life. I would decide myself. If I was in Canada I would not be living with you and would have gone after my own life, so don't insist..." After talking for about 15 minutes and ... I said goodbye to her.

After the phone call was finished it was the turn of Col. Georges and Ms. Paria , and they began giving me their despicable advices, such as: "... this is your last chance; if you don't come now, you will never be able to come and ..."

And I told them, "What do you want from me? Make the necessary arrangements for Mohammad as soon as possible and that would be enough for me."

Seeing I was firm on my decision they finally gave up their efforts.

On his last day in Ashraf I went to say goodbye to Mohammad and he returned to Canada the next day.

### **Targeted Efforts and Daily Increasing Pressures**

In May 2005 I was informed again that Mostafa Mohammadi had come to Ashraf. However, he had not come to us and instead he went to see US forces in charge of TIPF, telling them he wanted to take me back to Canada.

I was very surprised and couldn't believe it. I thought why he was doing so and I thought I had misheard it.

He wanted to meet me in the US forces' base located in Ashraf.

I went to the meeting to clarify the issue. US forces brought him to the meeting room. I kept on thinking what was going on and I asked him why he had gone to the Americans, while he always used to come to see me when he came to Ashraf .

Without answering my question and while becoming very angry, Mostafa Mohammadi said very aggressively, *"This is the last time that I am coming to see you! Your mother insisted on you coming back, and she is waiting for you and you must come back with me to Canada."*

For this very reason he had brought all the necessary documents for my departure from Ashraf along with Canadian citizenship papers.

Without even asking any questions, or respecting my decision and choice as a mature and a knowledgeable person about my own future, he considered himself to have full authority on me and wanted me to give in to his demands.

It is worth noting that without providing any explanation he was filming and voice recording his meeting with me. His behavior was no similar to the emotions of a father meeting his child. In fact, it was clear that he was on a mission with a special task.

He kept on filming me and said: “Send a message to your mother and tell her that I did everything for you but you yourself are not coming.” Of course he continued and repeated his remarks to place more pressure on me, and even said: “Your mother will die if you don’t return.”

I mean to say that his approach and behavior towards me had completely changed. His postures had changed and he had no control on his behavior whatsoever. He became angry all of a sudden, and then instantly calmed down ...

When I repeated my negative response to his insistence on me leaving Ashraf, he became hysteric and yelled at me, insulting me and the PMOI. In fact, he was carrying out his mission and was conducting the task he had been dictated to perform.

In reaction to his insistence, I told him to stop all this nonsense, put all this aside, and rest assured that I have knowingly chosen my path of life and I have nothing more to say to him or anyone else.

But he wouldn’t give up and kept on pressuring me.

As a result, I decided to inform the US forces in charge of Ashraf’s security and share with them my protests regarding this continuing psychological torture, which was repeated many times and conducted at times with US forces’ commanders being fully informed and accompanying Mostafa Mohammadi.

I started my private meetings with them in this regard, specifically without any other PMOI members or Ashraf residents present.

They were able to ask any questions and discuss in any way to evaluate and become completely assured about my true and free decision.

In this regard I explained to them that it was a filthy game of the regime’s intelligence pursued through my family against Ashraf and the PMOI, including myself, and trips and visits by Mostafa Mohammadi and other family members, were no longer under the framework of family reunions. Therefore, I am not willing to have any meetings with them at all.

In my meetings with US commanders, including Col. Overman, then commander of Ashraf’s security, I referred to this fact that I am not an immature person under the guardianship of others, including my family, for them to decide for my future. I informed them that I have chosen to continue my path as a PMOI member for the freedom of the Iranian people, and continuing and insisting on this decision is my own choice and I understand very well what I am doing.

I told them until I get the revenge of my people and our martyrs from this regime, meaning until this regime is overthrown and until freedom has been achieved for my people, I will not back down from the decision I have made in this regard and I truly cannot go back to an ordinary life.

Hearing my part of the story and getting the answers to their questions in a series of in-person and private meetings, the US forces commanders came to understand about my position and decision, and the lies and claims made by Mostafa Mohammadi and the MOIS campaign against the PMOI – claiming I have been kept in Ashraf against my will – and they no longer had any questions, doubts or misgivings in this regard. Therefore, despite previous cooperation by various US officers with Mostafa Mohammadi, following these series of meetings they confirmed my remarks and he was told he cannot impel his demands on me and force me to leave Ashraf.

They apologized for the atmosphere caused due to this issue and realized the suspicious purposes of Mostafa Mohammadi and his intention of taking me away.

It is worth noting that following the 2003 Iraq war, US forces were in charge of Ashraf's security. We were officially recognized as protected persons under the 4<sup>th</sup> Geneva Conventions in 2004. Therefore, wherever the fingerprints of the Iranian regime and the MOIS were seen, and our security was at risk, the US forces command was responsible and must have responded to similar cases.

In this regard in an Iranian Resistance conference in Paris, Col. McCloskey from the JIATF command at Ashraf pointed out the plotting and placing pressures through the MOIS and its agents against Ashraf residents. This included testifying on continuous visits paid by Mostafa Mohammadi behind Ashraf's gates seeking to separate me from the PMOI, all putting an end to claims about me being kept by force in the PMOI.

### **Testimony of Col. McCloskey – JIATF Commander at Ashraf up to 2008**

**Paris - 24 March 2012**

*"...Everybody I spoke to in Ashraf said they were there because they wanted to be there. I have had family members come to the gates and say my child is being held against her will. Mostafa! And he stayed at the gate day after day. And every time I would go in and I would talk to her (Somayeh), you're sure you want to stay here? And she would say: Yes!"*

Mostafa Mohammadi who had been recruited by the MOIS, in addition to being focused on separating me from the PMOI and making me leave Ashraf, was tasked to carry out another mission simultaneously

during his repeated visits to Ashraf since 2005. His new mission was to take films from all scenes, actions and interactions, especially his talks with me.

After becoming a full-time MOIS agent, little by little he dragged other members of the family into the fiasco and placed them at the disposal of MOIS, the most notorious agency in the Tehran regime involved in crackdown and crimes.

In his meetings with US forces he made a huge show out of it and began crying and yelling out loud at me, trying to have influence on me and making me passive, and bringing the Americans to support him and his mission, i.e. separating me from the PMOI.

He also secretly took video footages and pictures of US officers (as revealed in aired MOIS footages) in line with his other mission. He placed these footages at the MOIS disposal to be used in his so-called “TV documentary”. These footages have recently been aired by the Iranian regime’s state media outlets (including channels 1 and 2, Press TV and ...) and the abovementioned scenes are also included.

After this incident for some time I actually felt sorry for him for falling into a filthy trap placed by the MOIS. I thought this was all over, and when he saw I am staying firm in Ashraf he would finally let go of me and I could take a sigh of relief.

### **Continuation of Conspiracy & Psychological Torture**

Mostafa Mohammadi and my mother went to Jordan on 5 May 2006 in order to resume their pressures on me to separate myself from the PMOI so they could take me to Canada.

In a telephone call with them in Jordan on 6 May 2006 they acted much worse than ever before and said things I had not heard before. In addition to repeating MOIS propaganda and smear campaign against the PMOI, its leadership, its lifestyle and relationship between the members, they threatened me that if I did not return back with them they would take action against me!

This included my mother repeating the regime's known and absurd rumors in order to pressure me by threatening: "If you don't come with us, I will come to Ashraf's gate and set myself ablaze."

She also said, "Come here and don't waste your time over there, don't waste your young life, you're killing yourself, don't you know they [PMOI] have killed some people [their own members]..."

I didn't expect such remarks from her and couldn't believe that Mostafa Mohammadi had forced her into playing into the hands of the MOIS. So one can easily guess what Mostafa Mohammadi said and behaved in that phone call and there is no need to repeat it here.

As a result, there was no doubt left and it became clear to me that these remarks and concerns have nothing to do with family emotions and relations. The only thing they are related to and are directed from were the mullahs' notorious MOIS, or else they knew very well that my coming and remaining in Ashraf was based on my own decisions and beliefs, love and faith in this struggle for freedom. And no one can ever take my choice and beliefs from me, or impose anything else on me.

Considering these facts, the question was that who was behind all this insistence for me to return to Canada along with repeating the mullahs' propaganda and allegations against the PMOI to make me turn my back on the PMOI and my struggle.

Finally, once again I firmly told them what I believed in: Don't waste your time, and go back. I have nothing to do with you, I will not go anywhere with you, and goodbye.

I also told a number of senior PMOI officials, including Mr. Hossein Madani, one of the slain PMOI members of the 1 September 2013 massacre in Ashraf, who repeatedly had asked me to go with my family back to Canada, that my first and final word was that I have chosen my path and chosen once and for all to live as a PMOI member, and die as a PMOI member. Therefore, I am never willing to succumb to such despicable plots of MOIS, betray the PMOI, and leave the frontlines of this struggle.

I must admit that from the repeated emphasis of PMOI officials who said, “Think again and make a decision”, and especially regarding this suggestion of going back to Canada along with my family, I became very upset and it was truly a personal issue for me. This question kept on running through my mind on why they are suggesting something like this? I am a PMOI member and to this very moment, despite all difficulties and tests I have gone through, I have never thought of defecting from the PMOI even for one moment.

There I truly came to realize very well that as a female PMOI member I must first and foremost pay the price of my freedom and free decision to join this struggle in the face of any challenges and obstacles, and against all plots carried out by the Iranian regime, including taking advantage of family relations and emotions. The reason is that to fight this regime and the inhumane mullahs, and remaining in this path is never an aimless move and is not a decision without a price; in fact, one must pay the price in each step of the path.

This was how I made a vow to myself that against all the conspiracies the enemy – under any guise and pretext used against me – I will turn that into an opportunity to expand and increase my struggle and perseverance, and to grounds to deliver a blow to the mullahs’ regime by unveiling and defeating such plots, instead of regret and losing my patience in the face of this continuous psychological torture that the Iranian regime was carrying out through my family, and instead of getting annoyed regarding the suggestions provided by senior PMOI officials to “go back to Canada with my family”.

There is no need to explain that the Iranian regime and MOIS taking advantage of “family” relations and emotions was not just focused on me.

The Iranian regime made its utmost efforts to impose pressure and use various types of threats and bribes to use the families of other PMOI members to advance its goals against the organization. Regularly, caravans of various family members were formed and sent by the regime to Ashraf from Iran under the supervision of MOIS elements. Of course most of the families rejected the regime’s offer and accepted



the resulting consequences and pressures. Many of them forced to come to Ashraf in MOIS caravans began unveiling the MOIS plots and agendas once they saw their loved ones in Ashraf. They also showed the utmost sympathy and support for the PMOI and their relatives in the PMOI, and they were very much touched by the PMOI's humane and resistance values. Practically, they became couriers and preachers of Ashraf and Ashrafis inside Iran.

It was for this very reason that after a short period the mullahs considered as a red line any visits inside Ashraf for people it used to bring to the camp through any type of threats or bribes. Ultimately, after more than two years, they were kept behind Ashraf's gates and through a 24/7 psychological warfare around Ashraf with 320 loudspeakers, where they were yelling and threatening to murder and massacre all Ashrafis. They also expressed the most repulsive remarks by the so-called family members of the PMOI. In short, in the end a very small number were willing to sell their souls to the Iranian regime and become at the service of its agendas against the PMOI.

THROUGH MY EXPLANATORY LETTER ABOUT THESE MEASURES, I EXPOSED AND REVEALED THE FALSITY OF THE REGIME'S PROPAGANDA THAT IS BEING PROMOTED IN STATE-RUN NEWS OUTLETS AND MOIS WEBSITES.

**Letter to the Commander in charge of U.S. forces in Ashraf**

**8 May 2006**

This is Somayeh Mohammady, with ID Card No. 5E8FDDAB, residing in Ashraf. On the 5th of May, 2006, I learned that my family is coming to Ashraf for the sixth time. Presently, they are in Jordan waiting to receive entry visas. In all of my family meetings since March 2003 up to my latest contact on May 6, 2006, they are insisting and forcibly asking me to leave Ashraf. Yesterday, in particular, they put extreme pressure on me on the phone and threatened me that if I do not go with them, they will resort to practical measures and sabotage. After hearing their remarks yesterday, there remains no doubt for me that they are not concerned about my safety as immediate relatives, but unfortunately, they have been abused by the Iranian regime. In fact, the Iranian Intelligence Ministry has taken my family as hostage to force me to leave.

In the past three years in Ashraf City, the mullahs' Intelligence Ministry has repeatedly played this dirty game through families of other PMOI individuals in Ashraf. Families are brought to Ashraf, either on caravans or individually, to put pressure on the PMOI members to leave with their families. The same thing is being followed through international agencies, including Amnesty International and the International Committee of the Red Cross. The organizer behind all these activities is the mullahs' Intelligence Ministry.

For your information, I write a summary of every meeting I have had with my family. In all these meetings, I have said that I do not wish to leave Ashraf:

1. March 2003: In the final days before the war, my father, mother, sister and brother came from Canada to visit us. They asked me and my brother Mohammad, who was in Ashraf at the time, to return home along with them since the war was about to start. They were our guests for one week. During that week, I repeatedly explained my personal desires and wish to stay in Ashraf. Once, they learned of the views of Mohammad and I, they went back to Canada just one day before the beginning of the war and the PMOI paid for their travel expense.
2. The next time in November 2004, my father came to visit Mohammad and me. In this trip, he stayed as a guest with us for one month. Again, my superiors told me to freely choose if I want to return with him, but I said I did not wish to leave.
3. The third time was in December 2004 when my father was in Ashraf. My mother and sister also came to Ashraf and stayed with us for one week.
4. The fourth time was in March 2005, when my father and uncle came to visit us.
5. In July 2005, Mohammad and his superiors contacted my father and told him that Mohammad wishes to leave for Canada and you can come to pick him up.
6. In August 2005, my father came to Ashraf and stayed as a PMOI guest for three months. In this period, he followed up Mohammad's legal work and he returned with him to Canada, and I wanted to stay in Ashraf.
7. In May 2005, my father came to Ashraf and this time, he went to the U.S. forces based in Ashraf and asked them to hand me over to him so that he could take me to Canada. In this meeting, I encountered very strange behavior by him. He began to disturb people at the entrance of Camp Ashraf and he wanted to take me with him by force. This time, I had two private meetings with Col. Norman and Sergeant Bishop and I told them that I do not want to allow my father any more to disturb me and other residents of Ashraf. I also informed the above-said officers of my doubts about his suspicious behavior. I made my points in a letter to Col. Norman.

8. Now, after all these meetings, in a telephone call to Jordan yesterday, May 7, 2006, again they put me under pressure to return with them. In this telephone call, there were no more family talks but what the Ministry of Intelligence says against the PMOI. This leaves no doubts for me that they are playing the MOIS' dirty game against the PMOI in Ashraf.

I would like to draw your attention to this issue that I am an aware woman, 25 years old who has studied in Canada. I am completely aware of my present status in Ashraf and I do understand the meaning of my words and decisions. After six meetings, I do not want to continue this affair which is the desire of the (Iranian) Intelligence Ministry.

It should be noted that my family was the first to encourage me to come to Ashraf. Now they have become a pawn in the hands of the Iranian regime. I know them and I know that they under pressure from the Iranian regime. They are also aware that every time in our meetings, my superiors told me that I could leave if I wanted to, but my definite decision is to stay in Ashraf. At the same time, I have had this talk with the U.S. officers in Ashraf, time and again. The trend of measures taken by my family gives me this strong idea that they have made pledges to the Intelligence Ministry to have me return, otherwise no parents would put such tremendous pressure on his/her child.

- Today, my superiors told me that I can contact my father and tell him to come and pick me up. Like all the previous times, I have said I do not want to go.

- Because of the dirty game of the regime and their abuse of my family, I do not wish to see my family because they will put pressure on me.

- I asked the People's Mojahedin Organization of Iran to do not ask me to meet with my family against my will, as they did in May 2005. .... The Ministry of Intelligence of the Iranian regime wants to put pressure on me through my parents

## **CHAPTER 5**

### **IMPOSING PRESSURE THROUGH CANADIAN ORGANIZATIONS**

The Ministry of Intelligence (MOIS) did not limit its efforts to just hiring and using Mostafa Mohammadi, his family and launching a propaganda campaign in state-run media outlets in order to pursue this filthy war. In fact it took various measures attempting to have the government and formal organs of Canada (where I had come from) join its efforts. The MOIS resorted to different lies usually raised against the PMOI, especially by focusing on claiming I had been held in Ashraf and the PMOI against my will.

However, following consecutive telephone calls, meetings and interviews – all done in person and private – with representatives of the Canadian government and official organs, I informed them about the demonizing campaign against the PMOI by taking advantage of family relations. This included the baseless claims of me being held in Ashraf against my will, which I exposed, and underscored my free choice of staying in Ashraf and the PMOI. I also reiterated my repeated negative response to the pressures and demands of “my” family that were on behalf of the Iranian regime attempting to separate me from the PMOI and take me back to Canada.

This included a private interview in May 2004 with Canadian Embassy representatives in Amman who had come to Ashraf, where I once again told them of the truth and especially emphasized my decision to remain in Ashraf.

On many occasions I informed them about my decision to stay in private interviews and meetings with US government and the MNF-I representatives.

In May 2006 in a very lengthy interview over the phone with the Canadian Embassy, after providing explanations and answers to the representatives of this country, they became completely aware and certain about my decision to remain in Ashraf and the PMOI, and the fact that I am not willing to leave the bastion of resistance in the PMOI. They stressed their respect for my decision although they are concerned about my security and well-being in the current situation of Iraq; however, the MOIS continued its attempts to involve the Canadian government in this filthy war in its own favor.

The MOIS in November 2006 attached another notorious agent by the name of Saeed Sultanpoor in Canada, along with another flunky by the name of Niaz Salimi under the cover of “interpreter and middleman” as new members of this “family” team. Both individuals are Iranians living in Canada and work actively with the MOIS against the PMOI and other Iranian refugees. Niaz Salimi is working for the MOIS under the cover of the “Centre for Thought, Dialogue and Human Rights in Iran – Toronto”.

In this psychological war and smear campaign they wrote letters to Canadian officials and organizations repeating the MOIS’ propaganda and lies against the PMOI, meaning they launched a so-called campaign



about me. MOIS agent Sultanpoor wrote in his website: **“Campaign for the free determination of the future of all ‘Somayeh Mohammadis’ (link to Somayeh’s weblog)”**.

It is worth noting that “Somayeh’s weblog” was created by the MOIS misusing my name in this psychological warfare. I had nothing to do with the filthy text seen in that weblog.

I am writing to you in order to express my deep concerns regarding the safety of our client Mr. Mohammad Mohammadi as well as two directors of our organization including myself.

As Human Right advocacy group it is our foremost duty to question and challenge any system/individual that violates the fundamentals of the charter that we all believe in.

In the past few month we were working on behalf of a Canadian Citizen. Mr. Mustafa Mohammadi. and his family to facilitate the freedom of his young daughter from a military camp in Iraq that is under the control of this Iranian political organization known as »Mojahedin e Khalgh« or MEK.

Since the story of this family was picked up by national media and based on the interest expressed by National Post we collaborated with the NP reporter Mr. Stewart Bell. in various capacity from translator to mediator and the result was a five (5) part series that was published from September 23rd to September 28th on the front page of that paper with the mention to our Centre and repeated quotas from us. Needless to say, this report was not written in the favor of this organization.

Since this organization is active in Canada, as known by your office, the local members have informed their other pockets in North America and Europe hence an extensive campaign started against us. The regular attacks on their various media from TV/Radio programs to the papers and Websites accuses us as being the agents of Iranian Regime, a very old and overplayed rhetoric, and asks their members to »deal« with us.

Since the young Mohammad, he is the brother of the girl in camp Ashraf, was kept in that camp against his will for 4 years in the past he was the key witness in preparation of that article.

In the recent days and after the continuation of the threats he is very scared about his own safety which makes us uncomfortable too.

Since the clear instruction of this organization, as per their leader and stated in many of their publications, is to eliminate any individual who turns against the organization, defector, his concern for his safety is understandable. At the same time I and another director of our Centre Mr. Saeed Soltanpour, a well known journalist in our community, have been included in many of those threats and accusations.

Knowing the volume of the issues you are dealing with

we are not requesting any particular protection at this time but merely to inform you about the situation.

As Mostafa Mohammadi continued his subservience to the notorious MOIS and with the objective of placing me under pressure to defect from the PMOI, he requested from the Canadian government to renew my documents and also by referring to the fact that he is a Canadian citizen, he asked this country to accept me as a citizen. He went on to claim that I was being kept in Ashraf against my will and as if I sought to return to Canada!

Subsequently, Canadian government representatives, including Ms. Sonia Hooykaas, Vice-Consul of the Canadian Embassy in Jordan and Iraq, and other senior officials of this embassy came to Ashraf to assess the situation, meet me, and conduct another interview.

This meeting and interview was conducted without the presence of any PMOI member, with the US commander of Ashraf and other officers taking part. During this meeting once again I emphasized my decision to continue my struggle and not separating from the PMOI. By unveiling the measures and pressures imposed by the MOIS, I reiterated that their new pretext consists of requesting from the Canadian government to accept me as a citizen of that country, along with Mostafa Mohammadi bogusly claiming as if I am seeking to depart Ashraf but I am being kept against my will. I emphasized this has nothing to do with me and cannot keep me from the path I have chosen for my life.

Therefore, once again the Canadian government representatives, at the presence of US commanders, in a private meeting and interview (without the presence of any PMOI members) became informed of my true decision to remain in Ashraf and continue my struggle (despite a wave of lies and considering the correct data and true reports).

They also became informed about the MOIS' filthy war and demonizing campaign against the PMOI and taking advantage of "family affections".

#### **New MOIS trick fails after court ruling**

Another excuse of the MOIS and Mostafa Mohammadi used in the demonizing campaign against the PMOI by using me as a tool was referring to the Canadian Immigration Office Court. Without my permission, by hiring a lawyer in my name they tried to register lies in the Canadian immigration court that the PMOI have kept me in Ashraf against my will. The judicial hearing was held on 9 May 2006 in Toronto and I testified under oath from Iraq through a telephone link, at the presence of a US forces commander, that all these allegations were lies.

Based on such data and true reports the Canadian Immigration Office Court rejected Mostafa Mohammadi's claim that I was kept in Ashraf against my will, and thereby he had asked Canada to accept me as a citizen.

The Immigration and Refugee Board court on 19 September 2006 issued its ruling and once again rejected MOIS claims about me being kept in Ashraf against my will. It clearly verified that I am with the PMOI in Iraq upon my own decision. Hence, the appeals court turned down Mostafa Mohammadi's appeals request.

Through this court ruling, the conspiracy of using Canadian organs to change my decision and have me leave Ashraf and defect the PMOI failed once again.

2003 was arrested outside the notorious Evin prison while taking pictures of public protests there, and was later killed.

Suspected of being supported by the Iranian fundamentalist regime, Ms. Mohammady's parents have for years tried to prove that she had been brainwashed and held against her will, kidnaped by the PMOI. Without her consent, her parents even brought an application before a Canadian tribunal, the Immigration and Refugee Board, to try and secure her return to Canada. The judicial hearing was held in Toronto on 9 May 2006. The parent's strategy failed. Ms. Mohammady testified from Iraq by phone, under oath, and in the presence only of a U.S. Commander, that she was fine in Iraq, comfortable amongst her colleagues of the PMOI, and had no intention whatsoever of returning to Canada. The Canadian Immigration Tribunal ruled on 19 September 2006 that Ms. Mohammady had joined the ranks of the PMOI voluntarily and with the consent of her parents. The Tribunal further ruled that it was clear that Ms. Mohammady was a long-time committed member of the PMOI and that she wished to remain with her PMOI colleagues in the comfort of Camp Ashraf in Iraq, rather than return to Canada as was, and continues to be, the wishes only of her parents. The Canadian judicial proceeding reviewed all of the evidence, and concluded that Ms. Mohammady had not been brainwashed nor was she being held against her wishes.

Despite the ruling, the parents of Ms. Mohammady have again recently gone to Baghdad. Suspected of more support from the Iranian regime which will do anything to undermine the PMOI, the parents have now pursued a public campaign to try to denounce the PMOI and their own daughter.

Ms. Mohammady has met with her parents 9 times during the last 5 years, all of them to reassure them that she is fine and in no rush to leave Iraq and her duties with the PMOI. The last such meeting was held on 8 December 2007, during which Ms. Mohammady asserted: "I have no intention whatsoever to leave Ashraf. My decision to remain is based upon my commitment to the principles of establishing a democracy in Iran that respects human rights. It is from here in Iraq that I am able to fight for such justice."

Two senior Canadian officials from the Embassy for Canada in Amman, Jordan traveled to Iraq on 24 January 2008 to meet with Ms. Mohammady in Camp Ashraf. The purpose of the trip was to interview Ms. Mohammady independently, to once again determine if there is any credibility to the allegations of her parents. The Canadian officials offered Ms. Mohammady facilitated return to Canada, which she declined. Following that meeting, the senior officials went to Baghdad to confirm with Ms. Mohammady's parents her strong and freely expressed will to remain in Iraq, in Ashraf, among the ranks of the PMOI. It is thought that the Canadian officials also recommended to Ms. Mohammady's parents that they end their wrongful campaign and depart Iraq.

Today, Mr. Craig Bale, Consul at the Canadian Embassy in Amman, Jordan, confirmed the visit by Canadian officials to Ms. Mohammady and their report that she is healthy and happy to remain in Iraq.

Despite the clear expression of her free will, Ms. Mohammady has become the spark plug for a growing tension between Iran and Iraq, and the intervention by Iran in the internal affairs of Iraq. The PMOI are at the centre of this tension. There are regular reports in the Iraqi media about this case.

Reports by the Iraqi media indicate that under the Iranian Embassy's support an elite team of MOIS agents are lodged in the al-Mansour Hotel in Baghdad in order to pursue a plan to seize Ms. Mohammady.

Canadian lawyer Warren L. Creates, B.A., LL.B. represents Ms. Mohammady, and traveled to Ashraf in February 2004, to interview her and her PMOI colleagues, and to ascertain her circumstances. Mr. Creates, together with an impressive group of international lawyers in 15 different countries, fought and won the recognition pursuant to international law of each member of the PMOI as a "protected person" under the 4th Geneva Convention.

#### **A mission beside psychological torture**

General Stone,

I am Somayyeh Mohammadi, a member of the PMOI in the city of Ashraf. I was informed on Thursday, December 6, 2007 that my parents, who are now residents of Canada, have referred to US forces in Ashraf and have requested to visit me.

Due to your officers' insistence, I met with Lt. Harmon personally and told him that I have no intention to visit my parents because they have been abused by the mullahs' regime against the PMOI, and have been turned into a pressure lever against me and my organization. By sending my parents to Ashraf, the mullahs' regime, being aware of my firm decision on staying in Ashraf, intends to create this false impression in its psychological warfare that the people are kept in Ashraf by force. Last year when my father came to Ashraf for the same reason, during a visitation I told him that I did not want to have such visitations anymore; I informed Col. Turluck about that several times in our personal meetings.

It is about 10 years that I have left Canada and have joined the PMOI in Iraq willingly and freely to help the oppressed people of Iran more closely. Responding to the pressures imposed on me by Iran's ministry of Intelligence via my parents, I have informed different authorities repeatedly about my purpose and intent of staying in Ashraf; as an example, in May 2004, in a personal interview with the representatives of Canadian embassy in Amman who had come to Ashraf, I announced my decision on continuing my stay in Ashraf; also, in interviews and personal meetings with the representatives of US government and MNF-I, I informed them of my decision; and in the latest occasion in May 2006, I had a personal phone interview upon the request of Canadian immigration and asylum office during which the JIATF representatives were also present and I insisted on my previous decision. The outcome of such an interview was the ruling of a Canadian court to my favor that was also covered by Canadian press. This court was set up against me and my organization by the provocation of the Iranian regime's Ministry of intelligence.

I request you to recommend the JIATF officers in Ashraf to understand my situation so I won't be obliged to participate in any visitation or committing any action against my will, and not to put me in a situation or condition against my will. My understanding is that my personality and pride must be supported by your officers vis-à-vis the pressures by the Iranian regime.

I request that JIATF officers put an end on this conspiracy that Iran's Ministry of Intelligence has resorted to by misusing me.

Then on 7 December 2007 I had a meeting with JIATF commander LTC. Mark Harmon who requested to speak with me about meeting with my family. I provided explanations and emphasized the following: “I

*have no intention of meeting with them because they are in contact and cooperating with the mullahs' regime against the PMOI, and thus pressuring me and my organization."*

I also told LTC. Harmon that I have written letters of protest to General Stone in this regard on 7 December 2007 stressing they must bring an end to this MOIS conspiracy.

The purpose of this letter is to document the three criteria you stated must be provided to you in writing prior to a meeting with your parents:

a. Criteria One: You stated you did not have any intention on meeting your parents. Due to prompting by your leadership, you agreed to meet your parents, in an effort to alleviate undue pressures on the PMOI and the Coalition Forces. The meeting will occur at 1500 hours, 08 December 2007. The meeting will be held in the PMOI's facility on FOB Grizzly, which is also used for meetings on a regular basis between PMOI members and Coalition Forces.

b. Criteria Two: You have written three letters: one to your parents, one to the Canadian Ministry of Human Affairs, and one to MG Stone, Commander, TF 134. Those letters are in the possession of the JIATF Commander.

c. Criteria Three: That, I, LTC Harmon, be present at the meeting. My presence is to ensure that you are not exposed to any unnecessary dialogue that you find threatening or offensive. I will not be present to mediate; my impartiality cannot be compromised.

### Further Ultimatum and Warning to my Family

In addition to the letter to General Stone and in-person explanations for the JIATF commander in a meeting at his request, I also decided to write a letter to my family as a final ultimatum, emphasizing for the thousandth time the path and cause that I have chosen. I also warned them to stop their actions and



do not disgrace themselves with the infamy of the Iranian regime. The complete text of this letter is as follows:

*Hello,*

*Yesterday I learned about your arrival and I also explained the reason why I don't want to see you. I am aware of your activities during the past two years and the insults that you have written about me in the websites. Insults, such as brainwashing, that are very painful for me, and many other things that you said. But I didn't want to respond using your language. I am very sorry that things have turned out this way. I am still the same Somayeh and I still have the same opinions. It is very strange for me that you are thinking about saving (!) me, while we had talked to each other time and again. I truly wanted you to come to Ashraf like in the past and we could have had very good times together. It was just like that, but unfortunately you have now dishonored yourself by being in the same ranks of the enemy that killed Hadi and Hourieh, and 120,000 other PMOI members. Take this seriously: I have nothing to do with you. If you come again and again, another 100 times, and whatever you do, you will not see me, unless you literally cleanse yourself of the filth that you are now stuck in, and rid yourself one thousand times over of any traces of the Iranian regime and its criminals, and reveal the filthy path you went through with the MOIS by posting statements in the same websites and newspapers in which you wrote so many lies and insults about me. I am extremely upset about what you have done and I am truly ashamed of your lies and it is very unfortunate that it has come to this point.*

*Once I was proud of having a mother and father like you, and I always said my family helped me in finding the right path. And now, I know now that you are fully aware of the legal and political circumstances, and there is no need for the MOIS to manipulate you to save (!) me. You saw for yourself that when Mohammad wanted to return, we quickly informed you and you solved all the paperwork and measures necessary for him and he went on after his own life. Therefore, it is obvious to you and everyone else that if I had made such a decision no one could have changed that. And now, with all your commotion, you just cannot change my decision. I am not a little girl anymore that you may now think you can have domination on me. I have made my firm and ultimate decision. For how many years it may take I will continue my struggle against the enemy of the Iranian people and will never give up my struggle in this regard. I will not betray our martyrs. Take this very seriously and don't ever come to see me again for this purpose. Don't think you can truly do anything with these websites. They will all cost you in the end because everyone knows the PMOI and they all wish victory and the best for the Ashrafis. You may know that this regime will most definitely be overthrown and is surpassing its final days. You are mistaking in continuing your cooperation with them. I suggest that you pull yourself out of this filth. For the freedom of the Iranian people, and not just for me, but for our family and our two beloved martyrs "Hadi and Hourie", I wish and hope that you cleanse yourself of this regime so you won't be embarrassed with your heads down in the free Iran of tomorrow. Ashraf is a place for pure heroes who have sacrificed their all, and the right thing was for you to support me in this path. I am in contact with other members of my family (grandma and Uncle Hassan) and I am happy that they are not in this dirty path as you are. Rest assured*

*I am truly ashamed of your actions. For yourself and for the future of my brothers and sister, I am asking you to put these filthy practices aside and expose them. If you love me, then listen to me and come to realize your mistake. You will reach nowhere with what you are doing. If you come back a hundred times moreover I will not budge at all and you won't see me. I have chosen my path and I have complete faith in it.*

### Letter to Canadian Human Affairs Ministry

I also wrote a revealing letter to Canadian Foreign Affairs Minister Maxime Bernier in which I referred to the MOIS' dirty war by misusing my family and dispatching them to Ashraf over and over again despite being aware of my decision. I also reminded my private interviews with Canadian government representatives at the presence of US officials. In this letter time and again I emphasized my decision to continue with my struggle and remain in Ashraf, and invalidity of the allegations raised by the MOIS, including their claim about me and others being held in Ashraf against our will. In that letter I requested the Minister to take measures at stop the MOIS from misusing Canadian organs in this filthy war:



### PMOI officials ask me to meet with my family

As I explained above, once I became aware of my family coming to Iraq for the seventh time in order to intensify and pursue MOIS projects, I spent two days writing letters, making phone calls and talking to relevant agencies to reveal and neutralize the vile efforts of the Iranian regime and its agents. Moreover, despite the fact that I truly did not want to meet my family, at the request of PMOI officials I accepted to meet them and this unwanted meeting took place on 8 December 2007.

During this meeting I was reluctant to talk with Mostafa Mohammadi at all. I only reminded him that so long as he continues his cooperation with the Iranian regime and fails to ask for forgiveness from the PMOI, I don't consider him as my father.

ما قصة سمية مصطفى محمدكي المحتجزة في سجون منظمة خلق الإيرانية؟

حوار/سمير العراقي

شكلت منظمة متاهدي خلق الإيرانية هاجساً متخيفاً لأغلب العراقيين والإيرانيين على حد سواء؛ لارتباط تلك المنظمة بمماريات النظام السابق وأصبحت الجهة التنفيذية لها من خلال تنفيذ عمليات الاعتقال والتجنس على المعارضة الوطنية آنذاك. ولعبت المنظمة أسوأ دور لها في الانتعاش الشيعية الشعبية في العراق إذ تدخلت بشكل مباشر في قمع واعتقال وإغتيال قياداتها؛ فضلاً عن دورها في تجنيد الشباب الإيرانيين المقيمين في الداخل والخارج وأغرائهم بالمال والخلام الدراسة أو السمر. وكانت إحدى صفتاتها المواطنة الإيرانية الأصل سمية مصطفى المقيمة في كندا بالسمر إلى ألمانيا لإكمال دراستها وهي تم التوجه إلى التلخج لكتهم اغفلوها وسجنوا حوار سمرها وأجبروها على العمل في المنظمة داخل الأراضي العراقية. ولأجل الوقوف والتعرف على القصة الكاملة إخرينا هذا الحوار مع والد الشابة سمية.

كيف ومتى قدمت أنتك وكيف عرفت أنها لال في العراق وفي مسكر أشرف التابع لمنظمة خلق؟

-قدمت أنتك سمية إلى العراق عام ١٩٩٨ وفي بمر (المرافقة) وعرفت أن سمية توجهت إلى منظمة متاهدي خلق وذلك بسبب الدعايات والأشاعات الكاذبة التي تقوم بها المنظمة في كندا وعرفت فيما بعد بأن هذه المنظمة تقوم بتجنيد الشباب والنسبة من سن ١٢ سنة إلى ٢٠ سنة وتقوم بأغرائهم ثم تقوم باحتجازهم وحجز حوار سمرهم وكانت أنتك سمية ومجموعة من أصدقائها من ضمن المحتجزين منذ عام ١٩٩٨.

استلمت رسالة من أنتك سمية سنة ٢٠٠٠ وسنة ٢٠٠٢ في أيام العيد.

\* وهل كان لأنتك اتجاه سياسي معين؟

-لا يوجد لها أي اتجاه سياسي بل إن مختارات منظمة خلق تقوم بأغراء الشباب تحت السن القانوني وهذا ما جعل السلطات الكندية تطارد بعض عناصر المختارات في هذه المنظمة وقد كتبت الصحافة الكندية عن مافيات تجنيد الأطفال وإرسالهم إلى العراق، أنتك كانت طالبة وتدرس في كندا في تورنتو وهي من مواليد ١٩٨٠ تم اغرائها على أساس أنها سوف تحصل على دراسة في ألمانيا ثم إلى إحدى دول التلخج.

\* هل التفت بأنتك في العراق؟

-نعم تم اللقاء قبل سقوط النظام ٧ أيام وأرادت منك أنتك الذهاب معي إلا أن مسؤولي المختارات في المنظمة وبعض المختارات العراقية جعلوا الأمر أكثر تعقيداً حيث أرادوا تصيدي وهددوني بالفشل إذا تكلمت عن أي شيء.

\* وما الذي هددك؟

-مسؤول المختارات بهزاد سماري الذي لم يكن إنساناً بل كان جلاداً حينما قالت لي (بيبي) (يا) هذا أكثر جلاد وليس لديه (رحمة) خفيفة اردت أن ابعد بأنتك لكتهم رفض كانت أنتك تقول يا أريدك أن تنشر أكاذيب هذه المنظمة وتقول للشباب أبائكم وأن تصدقوا بمنظمة خلق، لقد تم نشر هذا المقال في جريدة ناشونال بوست الكندية واليوم نشرته في جريدة البيئة الجديدة لاني أعرف مدى حضورها في العراق وفي كندا من خلال ما يفره أصدقائي العرب على (النت).

\* وماذا تريد من الحكومة العراقية؟

-أريد من الحكومة العراقية أن تساعدني في اخراج أنتك من هذا المارق الذي هي فيه وأنا اتعهد للحكومة بأن أنتك بريئة ولم يوجد لها أي نشاط ضد الشعب العراقي سوى أنها دعتني من قبل مافيات المنظمة وهذه المافيات لا تمت للإنسانية بأي صلة.

\* وما هي رسالة مصطفى رجوی بثل مسعود رجوی؟

-مصطفى رجوی مصطفى رجوی رسالة يشرح فيها أعمال هذه المنظمة اللاإنسانية إتجاه من يقع في أيديهم من الشباب وأن اطلب من منظمات المجتمع المدني ووسائل الإعلام العراقية وأصحاب الضمير أن يعيدوا لي أنتك.

\* وهل كان لديك لقاء مع المسؤولين في كندا؟

-نعم كان لي عدة لقاءات هناك وهناك العشرات من الموائل تحت وطالب الرأي العام بالضغط على منظمة خلق من أجل أن يكون هناك لقاء بين أهالي الممر بهم مع ذويهم وترك الحرية لهم دون سرق بالعودة مع عوائلهم.

\* وماذا قالت لك أنتك عندما التفت بها؟

-أنتك بكت وهي بادمة خاصة أنها تنظر به الحكومة العراقية من عمل إنساني إتجاه الكثير من الممر بهم وأن أنتك قالت لي بأن الكثير من عناصر المنظمة هم الآن مصابون بالكاية) وأن أكثرتهم بادمون وبريدون الفرصة لكي يعودوا إلى ذويهم.

\* وهل كان في كندا تحرك للرأي العام إتجاه أنتك؟

-نعم وقد تم نشر صور أنتك واليوم نشرها في صحيفتكم وعداً في الصحافة الأمريكية.

\* وماهي رسالتك الأخيرة وماذا تريد أن تقول عبر البيئة الجديدة؟

-أقول إن حكومتكم وطنية وأطلب من السيد المالك أن يتدخل شخصياً لأن الفارخ سوف يكتب له خاصة ونجى على أبواب عيد الاضحى المبارك وأشكر جريدة البيئة الجديدة التي نشرها التحاليل العراقية وهم الذين حمزوني للاتصال وأطلب من جريدتكم أن تساهم وتمنع من خلال أعلامها الشريعة أي منظمة تعمل ضد العراق ودول الحوار لأن العراق هو بلد الأنبياء والرسل

What is the story of Somayeh Mostafa Mohammadi, a prisoner in the Iran Khalq Organization prisons?

Interview with Samir al-Iraqi – The People's Mojahedin Organization of Iran, due to its relations with the former Iraqi intelligence organization and the fact that it became an operations arm of that intelligence service by carrying out assassination and espionage against Iraq's then national opposition, became a source of concern and fear for most of the Iraqis and Iranians. This organization played the worst role in the Sha'baniya popular uprising in Iraq, interfering directly in the crackdown, arrest and assassination of that uprisings' leaders. In addition to its role in recruiting young Iranian s inside and abroad, and inciting them with money and dreams of education and trips abroad. One of these victims is Somayeh Mostafa Mohammadi, an Iranian citizen living in Canada who was enticed and went to Germany [mistake in the original text] to continue her education, and then go to the Gulf. However, she was arrested, had her passport confiscated and impelled to work with the organization inside Iraq. We have conducted a full interview with the father of Somayeh, this young girl, to get the complete picture of this story...

On 10 January 2008 the al-Iraqiya TV (mouthpiece of Maliki's government) aired similar lies, as ordered by Iranian regime officials, through Mostafa Mohammadi and other agents and terrorist Quds Force against the PMOI.

Al-Iraqiya TV also cited Mostafa Mohammadi claiming Somayeh Mohammadi (meaning me) had been kidnapped by the PMOI, and was being kept in Ashraf against her will and under pressure.

**پدر سمیہ ربودہ شدہ:** من از دولت عراق از رئیس جمهور، آقای طالبانی و نخست وزیر آقای نوری المالکی و تمامی مقامات دولت عراق می خواهم برای نجات دخترم از دست سازمان مجاہدین خلق راہ حلی پیدا کنند. سمیہ داوطلب پیوستن بہ سازمان نبودہ است بلکہ توسط این سازمان فریب خوردہ و توسط اطلاعات سازمان زیر فشار قرار دارد و از این موضوع بہ شدت نگران ہستم.

**گزارشگر:** سمیہ کہ در کانادا بہ منظور تکمیل تحصیلات متوسطہ بہ خانوادہ خود پیوستہ بود، دختر کوچکی بود کہ در آرزوی تحقق عدالت انسانی بود و برای دست یافتن بہ آن از طرف بہ اصطلاح سازمان مجاہدین خلق بود.



**مادر سمیہ:** سمیہ من سہ سال بود کہ بہ کانادا آمدہ بود. از دولت عراق خواستار دخالت ہستم و در این خصوص درخواست رسمی ارائه کردہ ام. دخترم برای ادامہ تحصیل بہ کانادا آمدہ بود، اما بہ دام سازمان مجاہدین خلق گرفتار شد. از تمامی مادران بہ اسم انسانیت جہت کمک بہ من برای نجات دخترم از دست این سازمان استمداد می طلبم.

**گزارشگر:** سازمان مجاہدین خلق کہ مقر آن در عراق می باشد، باعث جدل در محافل سیاسی عراقی می باشد، چرا کہ قانون اساسی عراق فعالیت سازمانہای متدرج در لیست سازمانہای تروریستی را ممنوع کردہ است و بر اساس گفته برخی منابع رسمی، دولت عراق درصدد اجرای اقدامات قاطعی ضد سازمان مجاہدین خلق می باشد.



**دکتر فاضل الشویلی، مشاور مطبوعاتی وزیر امنیت ملی:** طبعاً الان سازمان مجاہدین خلق در یک منطقہ جغرافیایی مستقر می باشد، این خاک و یا قرارگاہ، بہ نظرم اسم آن قرارگاہ اشرف باشد، این خاک ملک یک شہرہند عراقی است و استادی ارائه کردہ و این شہرہند عراقی برای پانزہس گرفتن خاکی شکایت کردہ است، یعنی الان سازمان باید آنجا را ترک کند.

**گزارشگر:** سمیہ یاب سؤالات زیادی را حول فعالیت واقعی سازمان مجاہدین خلق کہ مسئلہ حضور آن در عراق متبع جدل گسترده ای بین محافل سیاسی عراقی است، گشودہ است و شاید موضوع سمیہ این جدل را برای آخرین بار یا حضور و یا رفتن سازمان، تعیین تکلیف کند. تأمر الشمری، العراقیہ، بغداد.

### Al-Iraqiya TV reporter: Iranian family called PMOI responsible for abduction of their daughter

One Iranian family held the PMOI responsible for the abduction of their daughter who had been studying in Canada before the overthrow of the previous Iraq regime. This family asked the Iraqi Government to intervene to save their abducted daughter or at least inform them of her fate.

Based on revelations made by Somayeh's father - having an Iranian nationality - who has come to Iraq after a long life in Canada and after his daughter was trapped by the so-called PMOI, this father has no desire but to save his daughter from captivity and is seeking help from the Iraqi government to have his daughter released from this organization.

**Father of abducted Somayeh:** I ask the Iraqi government, the President, Mr. Talabani, and the Prime Minister, Mr. Nouri al-Maliki, and all Iraqi government officials to find a solution to save my daughter from the PMOI. Somayeh hasn't voluntarily joined the PMOI; rather, she was deceived by this organization and is under pressure by this organization's intelligence, and I am extremely concerned.

**Reporter:** Somayeh, who had joined her family in Canada to complete her intermediate education, was a small girl who was seeking the implementation of human justice through the so-called PMOI.

**Somayeh's mother:** It was three years that my Somaiyeh had come to Canada. I ask the Iraqi government to intervene and I have presented an official request in this regard. My daughter had come to complete her studies but was trapped by the PMOI. I seek the help of all mothers, in the name of humanity, to save my daughter from this organization.

**Reporter:** The PMOI, stationed in Iraq, is a controversial subject in Iraqi political circles because the Iraqi constitution has banned activities of terrorist organizations, and according to some officials the Iraqi government is after some decisive measures against the PMOI.

**Dr. Fadhil al-Shuwaili, National Security Minister's press advisor:** Naturally, the PMOI is now residing in a geographical region, this land and this camp which I think is named Camp Ashraf, belongs to an Iraqi citizen and he has presented some documents. This Iraqi citizen has complained and wants his land back; e.g. the PMOI now must leave the area.

**Reporter:** Somayeh has opened a new issue of many questions about the real activities of the PMOI, whose presence in Iraq is a source of controversial discussions in Iraqi political circles, and maybe Somayeh's issue determines this controversy for the last time, either with their remaining or leaving Iraq.

These lies and rumors were then repeated by a series of Arabic and Farsi language websites associated with the Iranian regime.

## Unveiling and defeating MOIS' lying campaign in interview with Iraqi and Arab media

Facing a new wave of lies distributed by the MOIS in Iranian regime-linked media and websites through Mostafa Mohammadi in order to spread rumors and lies such as me being kidnapped by the PMOI and kept against my will, I began conducting a number of interviews with independent Iraqi and Arab media outlets and shedding light on the truth. These interviews received widespread coverage, including in Azzaman daily, Al-Siyassah, al-Shahed al-Mustaqel, Radio Sawa, al-Iraq al-Yawm, Ilaf, al-Ray (Jordan), al-Ray (Kuwait), al-Malaf and ...

- Other outlets:** "سміة محمدي لـ «الرای»: الاستخبارات الإیرانية وعملاؤها یروجون أكاذیب بأن «مجاهدين خلق» اختطفوني" (Samia Mohammadi to Al-Ray: Iranian intelligence and its operatives spread lies that the 'Mujahideen of the Islamic Revolution' kidnapped me). "الامن الوطني ینفی صحة المعلومات مصادر بريطانية: موظف كبير في إطلاعات ینفذ مهمات سرية في العراق" (National Security denies the validity of the information: A high-ranking official in intelligence operations is conducting secret missions in Iraq).

In these interviews I completely unveiled the Iranian regime's psychological torture and filthy propaganda campaign. I also explained that this wave of lies is the result of the mullahs' fear and hopelessness against the PMOI as their archrival, and this psychological war has continued for years.

Below are a number of examples of such unveiling published in Arab media.

An Iranian female activist rejects Iran's claims about her presence in Ashraf Mohammadi: Tehran is pursuing a psychological war against PMOI families



Somayeh Mohammadi is an Iranian female activist rejecting claims raised by the Iranian regime about being forced against her will by the PMOI to remain in Ashraf City, home of this organization in Iraq, and she is refusing to return to her family.

"This is an utter lie under the framework of a filthy psychological war the Iranian regime's Ministry of Intelligence is instigating against the PMOI and myself," Somayeh Mohammadi.

"Five years ago [ten years ago] I joined the PMOI in Iraq with my father encouraging me to do so," Mohammadi said yesterday in a press interview.

"During the past few years the Iranian regime has used my father to launch a psychological war, and through my father they have accused the PMOI of abducting me. This is while I am in Camp Ashraf and conducting my daily duties," she added.

"I have met with my family 9 times during the past 5 years, with the last case being on 8 December 2007, and I emphasized I have no intention of leaving Ashraf. Any decision I made was in complete knowledge and under my own will," Ms. Somayeh Mohammadi said.

"Our leadership has time and again gathered us and asked do we want to stay or leave; however, we have remained steadfast and remained because we have faith in our principles," she continued.

"After I moved to Canada with my family back in 1994, seeing the PMOI's public activities I saw new horizons opening before my eyes. The PMOI helped the families that had moved abroad to make ends meet in foreign countries," Somayeh Mohammadi said.

“These remarks and claims published in websites linked to the regime’s Ministry of Intelligence, buying some people with money in order to say there is no resistance against it,” Somayeh Mohammadi said holding Iran’s Ministry of Intelligence responsible for provoking this issue.

“The constant demand of ostracizing and expelling the PMOI from Iraq and enmity against Ashraf City is through this very standpoint; however, the perseverance of the PMOI in Ashraf and revealing 3,700 meddling actions by the Revolutionary Guards and Quds Force in Iraq has disrupted all its plans,” she added...





Mohammadi, who joined the PMOI 10 years ago after legally departing Canada, said in an interview with al-Ray daily, "I am on the verge of filing a judicial complaint in international courts against the 'al-Iraqiya' satellite TV." She also accused Tehran of being involved in the report aired by al-Iraqiya TV...

Somayeh Mohammadi, a member of the opposition People's Mojahedin Organization of Iran in Camp Ashraf, said to Iraqi media and publications her exit from Canada 10 years ago was completely legal and based on her own will, and she came to Camp Ashraf and Iraq based on her parents' agreement.

After her family said the PMOI had abducted her, US forces conducted investigations into her presence in Ashraf, she added. If we focus on the issue of her abduction we come to realize that this is completely impossible and is one of the seven wonders.

First of all, because PMOI members cannot leave Camp Ashraf that is currently under US forces' control and supervision. Secondly, abducting a woman from Canada and passing her through many countries to reach Iraq is a hoax. How could have the abductors pass through so many security organs of so many countries? Even if Somayeh was placed inside a diplomat suitcase, enjoying diplomatic impunity, this would still be impossible.

"I left Canada legally back in 1997 and my father was aware and agreed with me joining the PMOI. I have been in Ashraf for ten years now and time and again I have spoke with US officials in Ashraf," she said recalling her story of joining the PMOI. Somayeh Mohammadi in her interview with Sawa Radio calls on Iraqi MPs and human rights organizations to visit Ashraf and see directly for themselves the status of the organization's members and in what conditions they are living in, and also the psychological pressure and propaganda that are imposed on them from various parties. She also criticized the al-Iraqiya satellite TV network for broadcasting a report covering her father's claims that the PMOI has abducted her and called for her release.

Somayeh explained that she has a letter from the US commander in Iraq and others showing they have 9 times taken her testimony and these documents can presented in any court of law.

"I asked my lawyer Warren Creates in Canada to file a complaint against the al-Iraqiya TV network and also the Iraqi Foreign, Justice and Human Rights ministries, and I called on them to visit Ashraf City, and/or dispatch a delegation with the presence of US forces to be informed of all the details and circumstances of this plot pursued by the Iranian regime," she added.

To emphasize on her right to responde to these false claims and the truth of her reasoning, Warren Creates, Somayeh's letter wrote a letter to Iraqi President Jalal Talabani explaining details for him in this regard, and asked him to issue the necessary orders to review these false claims and also prevent any movements by Mostafa Mohammadi who has been officially recruited by Iran's Ministry of Intelligence...

**Iranian activist Somayeh Mohammadi accused al-Iraqiya TV of duplicity and carrying out orders issued by Tehran**

Somayeh Mohammadi, an activist of the opposition People's Mojahedin Organization of Iran, has begun responding to the al-Iraqiya satellite TV network that aired a report claiming she has been abducted by her organization.

We are writing as lawyers for the residents of Camp Ashraf, members of the People's Mojahedin Organisation of Iran (PMOI), and on behalf of 8,500 European jurists who support the rights of the members of the PMOI (as published in Frankfurter Allgemeine Zeitung on 31 January 2006, Daily Telegraph, 3 February 2006, The Times of London, 4 February 2006 and NRC Handelsblad, 5 February 2006).

On Thursday, 10 January 2008, Al-Iraqiya television network aired astounding lies at 15.00 and 20.00 hrs, against the PMOI and Ms. Sommayeh Mohammadi, who is a "protected person" under the Fourth Geneva Convention and a PMOI member residing in Camp Ashraf. This clearly shows that Al-Iraqiya television has been manipulated by the Iranian regime, its terrorist Qods Force, and its proxies in this Force.

In a telephone conversation with the deputy head of the news section of Al-Iraqiya television last night, invoking her rights, Ms. Mohammadi asked that the network retract the vicious and despicable lies against her. She said that U.S. military commanders responsible for the protection of Ashraf, who had been witness to nine different meetings between her and her family over the past four years, were fully aware of the bogus nature of these allegations.

By falsely claiming that Ms. Mohammadi had been abducted and pressured by the PMOI to stay in Ashraf against her will, the Iranian regime's Intelligence Ministry and its proxies in the Qods Force have tried to demonise their opposition. In doing so, they have also subjected Ms. Mohammadi to psychological pressure.

U.S. commanders in Ashraf, who have met Ms. Mohammadi and her family repeatedly, have testified to the falsity of these accusations in letters dated 23 October 2006 and 8 December 2007. You can also personally visit Ms. Mohammadi and talk to her in Ashraf at the presence of the U.S. commanders, to recognise what Al-Iraqiya had broadcast was totally false and bogus. The Iranian Intelligence Ministry and the Qods Force had disseminated these lies on nine previous occasions. Several letters to the U.S. commanders by Ms. Mohammadi and her interview on Iran National Television (INTV), leave no doubt as to the bogus nature of these claims. Competent Canadian officials are fully aware of the details of this case as well. Mr Warren Creates, LL.B., Head of Immigration Law Group, represents Ms. Mohammadi in Canada, and will pursue the matter through legal channels by filing a separate lawsuit in this case.



**Letter to General Stone**

**January 30, 2008**

*...This is the third letter I am writing to you concerning a plot by the Iranian regime Ministry of Intelligence and Information (MOIS) against me and the residents of Ashraf. You must be aware of the visit by the Canadian Consul to Ashraf and her meeting with me. This visit and the meeting we had proved to them that all the MOIS's allegations against me and the Ashraf residents were lies.*

*I am writing to you because my lawyers' efforts to give some reply to these allegations indicted that the Iraqi government is also behind this case and our efforts does not give any results. The official al-Iraqiya TV in an interview with my father attributed many lies to me and residents of Ashraf. In order to shed light on the truth, I made many phone calls to al-Iraqiya TV; finally, I managed to talk to one of the officials of this TV station and asked him to broadcast my denial. His reply was that they were ordered not to broadcast any denial from my side and that order was by the government controlled Council of Security-Political Board of Network. He told me that the order to interview Mostafa Mohammadi had been issued by the same Council.*

*You are also probably aware that through its agents, Iranian regime by abusing me has apparently acquired three warrants to arrest Ms. Mojgan Parsaei, Ms. Sediqeh Hosseini and Mr. Abbas Davari for allegedly keeping me in Ashraf by force. This all affairs puts me under pressure more than anything else.*

*I appreciate that you and your officers in Ashraf have tried to solve this issue in a proper manner, and I believed by the Canadian Consul's visit to Ashraf every thing would be finished but they are now engaged in plotting more conspiracies. Nowadays, the Iranian regime's media and news web sites have launched a psychological warfare against me.*

*My request from you is to ask the Iraqi government not to get further involve in this matter which is unjustly abusing me against PMOI, and ask them not to prevent the broadcast of truth about me.*

Dear Mr. President:

I am writing this letter to you as a member of International Committee of Jurists in Defence of the Rights of Ashraf Residents and also as the lawyer of Ms. Somayeh Mohammady.

Ms. Mohammady is a resident of Ashraf City in Iraq. She has the legal status of a Protected Person under the Fourth Geneva Convention. I personally visited Ms. Mohammady in Ashraf in February 2004, and since that time I have been her attorney.

Somayeh Mohammady previously lived in Canada with her parents. In June 1997, voluntarily and with the support and consent of her parents, especially her father, she departed Canada and joined the PMOI in Iraq.

On 10 January 2008, al-Iraqiya TV broadcast an interview with Mostafa Mohammady, Somayeh's father, at both the 15:00 and the 20:00 news broadcasts. During these news broadcasts the father claimed that his daughter Somayeh Mohammady has been kept in Ashraf forcefully against her will. Prior to this, some other media which are known to be affiliated with the Iranian Regime's Quds Force also published similar claims against the PMOI and Somayeh Mohammady by quoting her father.

The Iranian Regime has also announced in its state-run media that Iraq's Deputy Prime Minister has also met with the father. The father has been residing in Baghdad for over one month to pursue the intentions of the Iranian Regime's Ministry of Intelligence and the Quds Force. In this

regard he has launched a psychological campaign against both his own daughter and the residents of Ashraf.

Since 2003, Mostafa Mohammady (the father) has travelled to Iraq and the City of Ashraf seven (7) times in order to try to persuade Somayeh to leave the PMOI. However, Somayeh has clearly notified her father of her firm decision to voluntarily remain in Ashraf and to support the legitimate goals of the PMOI.

Last month when Mostafa Mohammady went to Ashraf, he asked the U.S. Forces to meet with Somayeh. Despite her personal objection, but after the PMOI officials' recommendations and the request of the U.S. Forces, Somayeh agreed and did meet with her parents in the presence of U.S. Commanders. During this meeting Ms. Mohammady reiterated her previous decision to voluntarily remain in Ashraf.

Over these years, Mostafa Mohammady has wrongfully attributed allegations to the PMOI such as "kidnapping children" and "incarcerating and suppressing" its members, and has set up a website and a fake charitable organization to collect money for the "salvation of Somayeh".

In 2006, Mostafa Mohammady unilaterally commenced an appeal in the name of Ms. Mohammady with the Canadian Immigration and Refugee Board claiming that Somayeh wanted to return to Canada but was forcefully kept in Ashraf against her will. A judicial hearing was held to review the case. In order to obtain her independent and voluntary evidence under oath, the Board Member of that Tribunal had a telephone interview with Somayeh while an American officer was present. The Board issued its decision on 9 May 2006. It ruled that Ms. Mohammady joined the PMOI voluntarily with her parents' consent. The Tribunal further ruled that it was clear that she was a long-time committed member of the MEK and wished to remain with her Mujahedin colleagues in the comfort of Camp Ashraf in Iraq rather than return to Canada (the reasons of the Tribunal are enclosed).

The letters of U.S. Commanders in Ashraf dated 23 October 2006 and 8 December 2007, as well as scores of letters to U.S. Commanders authored by Somayeh Mohammady and her TV interview with Iran National TV (INTV) about her father's behavior, together leave no doubt about the falsity of Mostafa Mohammady's claims and the origins of his provocations against his daughter and the residents of Ashraf.

The issue of Mostafa Mohammady is beyond a family issue. Rather it is a campaign of the Iranian Regime's Ministry of Intelligence against Somayeh Mohammady and the residents of Ashraf. By employing Mostafa Mohammady as a tool, the Iranian Regime seeks to demoralize Somayeh and at the same time incite the Iraqi government against the PMOI and the Ashraf residents.

The residents of Ashraf including Somayeh Mohammady are Protected Persons under the Fourth Geneva Convention, International Humanitarian Law, International Law and the Article 3 of the Geneva Convention. Iraq is a signatory to these Conventions. The conduct of Mostafa Mohammady clearly breaches the protections provided her as contained in these many Conventions.

I therefore request your Honour to immediately issue the necessary orders to prevent Mostafa Mohammady's ongoing unlawful conduct, which encroach upon the rights of my client, Somayeh Mohammady.

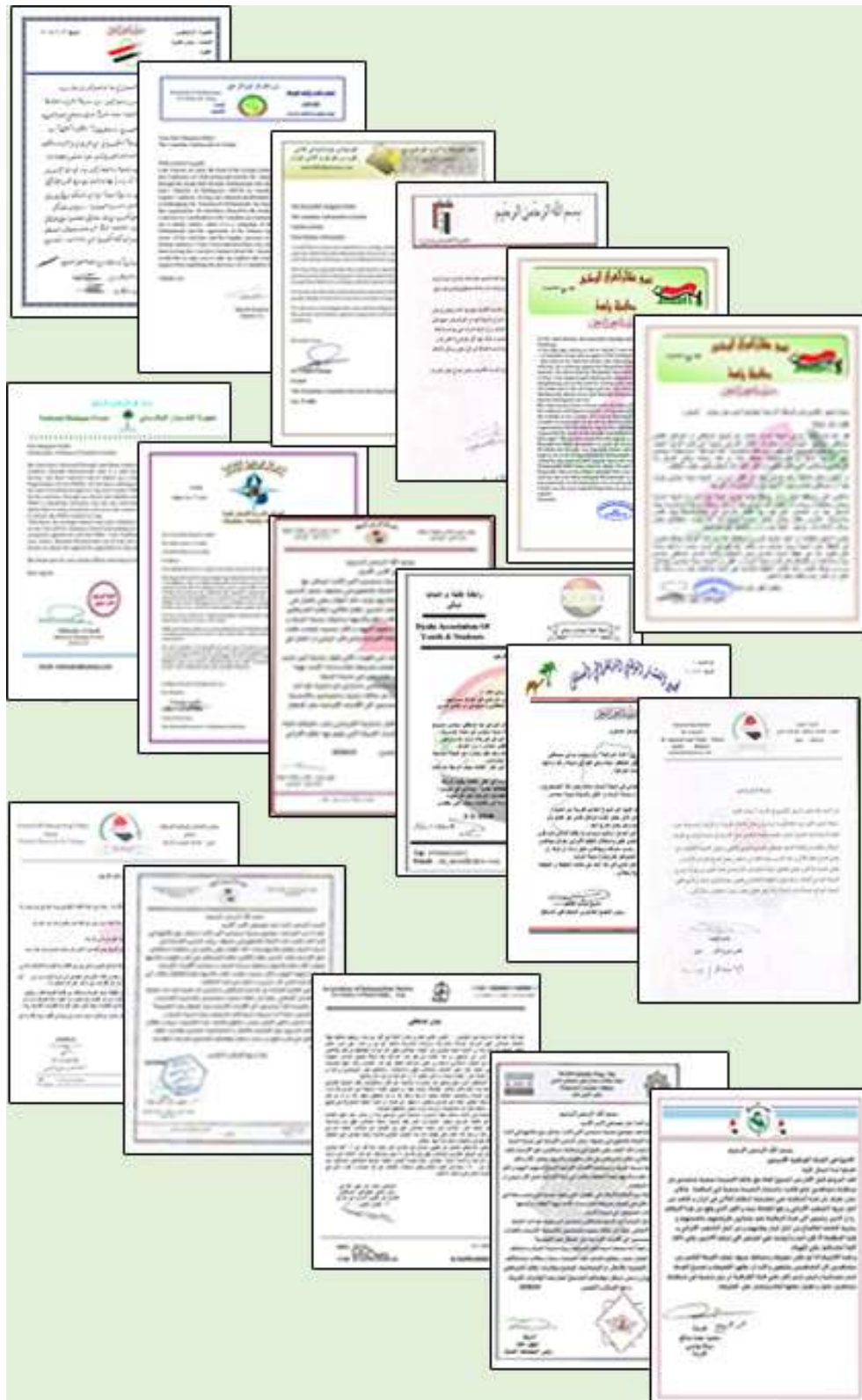

## **CHAPTER 8**

### **HIDEOUS MINISTRY OF INTELLIGENCE CONSPIRACY TAKING ADVANTAGE OF IRAQ'S JUDICIARY ORGANS**

Following the defeat of a series of the Iranian regime's political-propaganda measures and plots against the People's Mojahedin Organization of Iran, and the psychological torture against me by using my family that continued for years in an attempt to have me succumb to their demands, the Ministry of Intelligence in 2007 started using Iraqi judiciary organs against the PMOI.

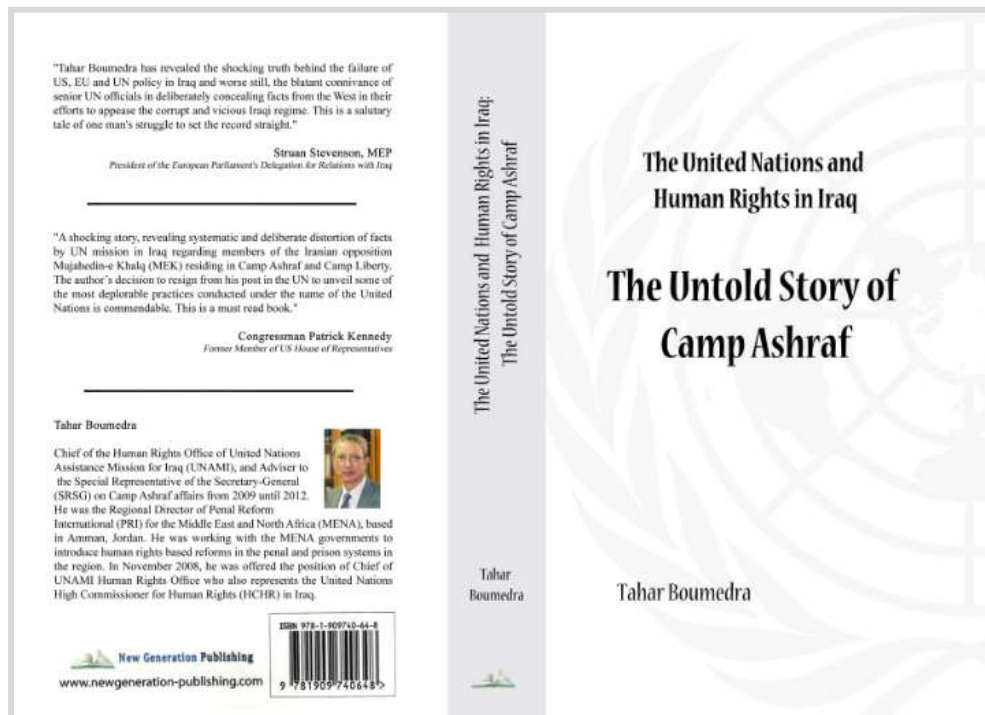
The Iranian regime's notorious MOIS took advantage of Mostafa Mohammadi and attempted to launch a judicial case against various PMOI officials through its despicable propaganda lies about abducting (!) and holding me in Ashraf against my will, along with other false claims.

This hideous measure and mass-producing fabricated protest letters – a known joint plot carried out by the Iranian regime and Maliki's government – is one of the hundreds of examples of mass-producing protest letters by the MOIS on various issues during the past 12 years against the PMOI. Below is a reference to a number of examples of the regime's claims:

**Tahar Boumedra, Director of UNAMI Human Rights Office and in charge of Ashraf's dossier (2009 to 2012) wrote in his book named "The Untold Story of Camp Ashraf"** referring to illegal remarks made by Judge Kadhem al-Aboudi, head of the Iraq Criminal Court in state-run TV against the PMOI, condemning them as terrorists and claiming they violated the principal of innocence. Boumedra came to the following conclusion:

*...The [Iraqi] judiciary had been so politicized and "sectarianized"; it had become a mechanism for settling historic religious and political scores...*





### *The Untold Story of Camp Ashraf – By Tahar Boumedra*

On 19 January 2011 Tahar Boumedra also declared to High Criminal Court and its chief judge that these rulings lack credibility, are political motivated and do not meet any international legal and judicial standards, adding they must be revoked altogether.

Boumedra in a session held on 16 October 2013 in Brussels, along with former Iraqi vice president Tareq al-Hashemi, said about the status of human rights and judiciary orders in Iraq:

*"...Mr. Vice-President, you may remember that Judge Aboudi who had the dossier of the so-called terrorist PMOI, I asked him in his office to show me every document he had against these people.*

*He put a lot of files on the desk and his secretary read the documents to me. Not even a file had a document that the court might refer to and condemn the individual. All of them were third hand or fourth hand rumors..."*

The Iranian regime Ministry of Intelligence took advantage of the Iraqi judiciary and also attempted to register similar cases in a court in the city of Khalis under the pretext of a "father whose daughter has been abducted by the PMOI" (!) against three PMOI officials in Ashraf.

Of course these fabricated allegations and so-called judiciary puppetry was more ignominious to bear any fruit for the mullahs because the tight legal and judicial aperture in Iraq's judiciary – that the mullahs' regime and their puppet Maliki government were not able to block and had yet to find – quickly brought an end to their plots planned by the Iranian regime and the mullahs' notorious MOIS on this issue, delivering a severe blow to all their scenarios. Therefore, as the Iranian Resistance leader reminded on 17 December 2007:

**“Wherever there is any sign of law, freedom and conscience, have no doubt, we will be victorious.”**

On the complaints made by Mostafa Mohammadi filed in the Kholes court, first of all I emphasized on the necessity to end this ridiculous fabrication of court files, which were all conspiracies of the mullahs' regime against the PMOI and its senior officials. I also requested a meeting with the investigative judge.

Given the restrictions imposed on Ashraf during that period, there was no possible way to exit the camp, and therefore on 2 December 2008 the investigative judge came to Ashraf to meet me, hear my side of the story in person and conduct his own evaluation.

In my meeting with him, conducted under oath, I explained the truth for him and emphasized that I am remaining in Ashraf and with the PMOI based on my own decision, and these complaints are nothing but the behest of the mullahs' regime and is not at all a family matter.

The investigative judge took his time and asked his different questions and registered my remarks and answers completely in this hearing. The Iranian regime, embassy in Baghdad and MOIS, along with their agents, went the limits to pursue their objectives through the same route. However with widespread revelations the efforts placed by the Iranian regime, its officials and agents saw nothing but defeat, and finally after three years of a serious legal-political campaign, this mullah-fabricated dossier was closed once and for all in 2010 with a ruling issued by the central investigative judge. This brought an end to the regime's fabricated allegations and calls for arrests to be made. Therefore, not only were the regime's efforts to take advantage of the legal leverage fell to deaf ears and failed, in fact it went further than that and the regime's claims of me being abducted and kept against my will by the PMOI was sealed by an Iraqi judiciary ruling; again adding to the embarrassments for the mullahs, the MOIS and their agents.

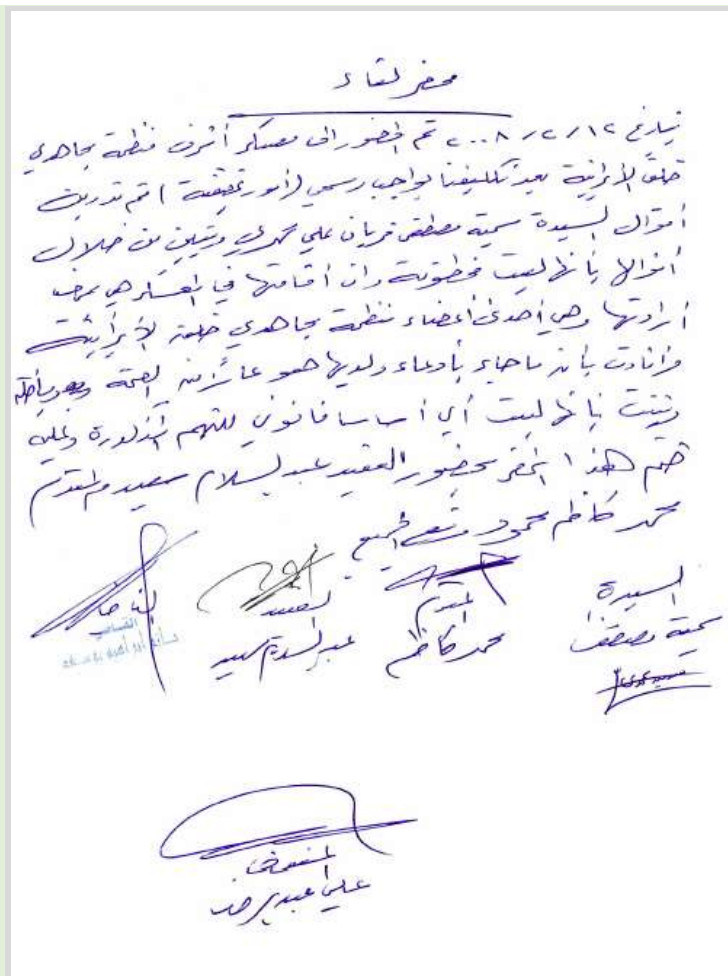

## CHAPTER 9

### PREPARING GROUNDS FOR TERRORIST ATTACKS AGAINST PMOI IN IRAQ

In addition to his mission in pursuing the Ministry of Intelligence project by psychologically torturing me to separate me from the PMOI and depart Ashraf, Mostafa Mohammadi along with other MOIS and terrorist Quds Force agents, and in continuous contact with the Iranian regime embassy in Baghdad, was stationed in suites paid for by the Iranian regime's embassy in Baghdad's five-star Hotel Mansour. They also pursued other missions against the PMOI and Ashraf, including paving the grounds for terrorist measures against Ashraf. Various aspects of these actions were revealed in the statements issued by the Secretariat of the National Council of Resistance of Iran. One can refer to the following:

The third statement NCRI statement (9 February 2008) on the bombing of the Ashraf water pumping station reads in this regard:

*"On February 8, the Qods Force terrorists in a cowardly act blew up the power station supplying water to Ashraf City residents and 20,000 Iraqis living in the vicinity. Also on February 6, a local tribe council member, Sheikh Hamid Ziab, in charge of power station was assassinated.*

*A number of MOIS and Qods Force agents are presently staying in Al-Mansur Hotel in Baghdad are identified as: Massoud Khodabandeh, Mostafa Mohammadi, Reza Akbari Nasab and Alireza Bashiri. The team leader for the group belonging to the Qods Force is Tabatabaie."*

The PMOI issued a statement on 12 February 2008 on the terrorist Quds Forces' criminal plan to stage missile attacks against Ashraf. The statement explained that a number of agents of the MOIS and Quds Force including Massoud Khodabandeh, Mostafa Mohammadi, Reza Akbari-Nassab are settled in in Hotel Mansour. They are under the supervision of Tabatabai, Nobakht, and Assadi, the agents of the Qods Force and the MOIS. The statement added that the Iranian regime ambassador to Iraq Kezemi Qumi met with them in Hotel Mansour on 7 February 2008.

PMOI statement – 11 April 2008

#### **Deployment of previously used agents against Iranian Resistance depicts Clerical Regime's extreme frustration**

In December 2007, a group of agents affiliated to the Qods Force and the MOIS were dispatched to Iraq from Iran and abroad for pursuing plots, filing complaints and launching disinformation campaign against members of the PMOI in the Ashraf City. They were settled in Hotel Mansour, under the command of the Iranian Embassy in Baghdad. Some of these regime's agents who had to reside in Iraq for three months to

carry out their missions are: Massoud Khodabandeh, Mostafa Mohammadi, Reza Akbari-Nassab, Taimour Khattar, and Alireza Bashiri.

The above mentioned agents resided in the third floor of the Mansour Hotel under the supervision of Tabatabai, Nobakht, and Assadi, the agents of the Qods Force and the MOIS. All the hotel bills were paid by the Iranian regime's embassy, and at first they participated in an absurd seminar titled "War against terrorism" in which 20 proxies of Tehran's regime were present.

The gatherings and the movements of the Iranian regime's agents drew attention of Iraqi entities too, and a number of them including "Association of Iraqi Intellectuals and Academics" and "Association of Independent Iraqi Jurists" issued statements to disclose and condemn this puppetry.

**Mostafa Mohammadi coming to Ashraf after US forces transferred camp security to Maliki's government**

US forces transferred Ashraf's security dossier in January 2009 to their Iraqi counterparts.

Instead of protecting Ashraf and Ashrafis, from then on a new chapter began full of siege, pressure, crackdown and massacre ordered by the mullahs' regime and carried out against the PMOI in Ashraf by forces under Maliki's forces. During this period plots and direct measures by the Ministry of Intelligence against Ashrafis reached a new climax. This included dispatching and stationing groups of their agents under the pretext of Ashrafis' family members at the front gate of Camp Ashraf, and by installing 320

strong loudspeakers around Ashraf for 677 days, launching 24/7 psychological torture on the Ashrafis. This is the most inhumane and longest- lasting series of pressures and harassments intended to force the PMOI surrender and succumb. In this period Mostafa Mohammadi was again and again dispatched from Canada to Iraq as a professional agent, and in one case he remained in Iraq for many months to carry out numerous assignments.

His main and permanent mission during this period was in line with the long-running project by resorting to using family relations and the mullah-fabricated claim of the “abducted child being held against her will in Ashraf”. Despite the revoking of this case in the Iraqi judiciary, he continued his activities in this regard through websites and other media outlets linked to the MOIS and terrorist Quds Force in Iraq. He was also very active in despicably participating in the smear campaign and vulgar language, along with threats to annihilate the PMOI, through 320 strong loudspeakers installed by the MOIS around Ashraf.

Another part of Mostafa Mohammadi’s missions, and similar agents in Iraq, was to take part in the propaganda puppetry staged by the Iranian regime’s embassy and MOIS to repeat the mullahs’ bogus claims against the PMOI under the pretext of holding “conferences”.

All the expenses and necessities in these trips from Canada to Iraq, that were repeated over and over again, along with the expenses of long stays with other family members, activities and carrying out various missions – all aimed at pursuing the Iranian regime’s projects against the PMOI – had no source other than the MOIS. At a very modest estimation, the expenses that added up through all these years were massive; especially for an individual like Mostafa Mohammadi who had no specific job or occupation, or any particular savings. He was a worker in a blacksmith shop and only knew how to make doors and windows.

In 2008 he had travelled to Iraq many times along with the mullahs’ internal and foreign-based agents, with a group of official agents and families working for the MOIS branch known as the Nejat (Save) Society. He planned various plots against Ashraf in his collaboration with the Iranian regime’s Baghdad embassy and agents of the terrorist Quds Force, along with the mullahs’ Iranian and Iraqi agents in Iraq, during his stay in Baghdad’s Hotel Mansour.

Mostafa Mohammadi was used by the Iranian regime’s embassy and MOIS alongside notorious agents such as Massoud Khodabandeh in Iraq for various missions against Ashraf and the residents. One of the MOIS’ front branches was the Sahar Foundation, which reported a piece on the meeting between a number of MOIS-linked ‘Nejat’ agents dispatched from Iran to Iraq, along with Mostafa Mohammadi, with Iraq’s then human rights minister on 2 December 2008. The objective sought in this meeting – prepared by the Iranian regime’s Baghdad embassy under the same pretext of family members being kept against their will in Ashraf – was to prepare the grounds to impose even more pressure on the PMOI and pave the path for attacks and massacres by Maliki’s government in Ashraf.





On Friday, 5 December 2008, a group dispatched by the MOIS, including a small number of those whose family members were in Ashraf, went to Ashraf's front gate to create a fiasco and make a major controversy. The reason was that previous meetings and pretexts were met with failures and dead ends, and repeating such measures was neither justified, nor would bear any results.

The next mission of these agents, including Mostafa Mohammadi and a number of others sent by the MOIS from Iran to Iraq, was to take part in the regime's mock sessions held in Baghdad's Hotel Mansour. This meeting was held on 12 December 2008 in which these agents participated with Arab-speaking agents of the Iranian regime and Maliki.

Mostafa Mohammadi in this session once again repeated the same Iranian regime-fabricated scenario (me being abducted by the PMOI!) with stage-managed shows.

A number of Tehran-linked Farsi and Arab language media outlets, including al-Motamar daily, Nejat, al-Alam and ... provided coverage for these sham sessions along with Mostafa Mohammadi's fiasco and prate.



The dispatched delegation also wrote a petition expressing their deepest gratitude to Nouri Maliki about the status issued for the PMOI in the Council of Ministers' 17 September 2008 session.

Expressing gratitude of this status actually paved the grounds for three massacres in Ashraf with over 100 residents murdered in cold blood and over 1,000 others injured, along with a comprehensive inhumane blockade and 24/7 psychological torture campaign that continued for 677 consecutive days through 320 loudspeakers.

I was informed again on 6 February 2009 that Mostafa Mohammadi, along with my brother Morteza, had once again come from Canada to Iraq and he was at Ashraf's gate demanding to see me. In this regard the Iraqi and US forces stationed in Ashraf had asked me to meet with him.

I went to see the US and Iraqi officers in order to talk and provide the necessary explanations.

They asked me to go outside of Ashraf to meet with Mostafa Mohammadi and Morteza.

However, I explained the background and Mostafa Mohammadi's mission assigned by the MOIS, adding I don't want anything to do with them and don't want to have any meetings or talks with them. When they were confronted with my firm opposition they asked me to take a picture of our meeting to show it to them (Mostafa Mohammadi and Morteza) so they can be assured that the US and Iraqi forces had informed me of their request to meet with them, and it is me that refuses to meet with them.

Of course, after this scene was repeated time and again, and seeing the suspicious and abnormal behavior and approaches from Mostafa Mohammadi in these series of visits, his status and connections

with the Iranian regime had become completely clear for the US forces, Canadian Embassy in Baghdad, ICRC and ... Therefore, whenever the MOIS groups would reach Ashraf the nature of his activities and fiascos were completely known for them. At times they would ridicule him and say with discomfort: "Here comes Mostafa again".

Mostafa Mohammadi: I went to see Ms. Wojdan Mikhail and said I want to see my daughter... under coordination we went to Camp Ashraf and waited, but there was no answer. We received a letter that Somayeh doesn't want to see you.

I wrote a letter but the Iraqi officers said Somayeh is not willing to receive your letter.

Last year I obtained an arrest warrant for the arrest of the leaders of this terrorist group and I have come from Canada to Iraq 14 times, yet all without any results.

My legal status in Canada was a refugee, but my documents have now expired.

In those days Muwaffaq al-Rubaie, Maliki's national security adviser had also said in his smear campaign, "These PMOI members have been brainwashed."

Each time he would describe another individual as the person in charge of Ashraf to supposedly look out for the Ashrafis to to, in his terms, save anyone that may be held against their will!





The Iraqi federal police commander, dispatched by Muwaffaq al-Rubaie to Ashraf, requested to meet with me. In this meeting US officers along with their interpreters and the police commander and his interpreter were present.

He told me:

**“... they have told me many things about you, that you are being kept against your will, you need help to get out of here, and ...”**

In response I said:

“These are remarks made by the mullahs’ regime that they have told you I am being kept here against my will and that I could not come and meet you. The clear reason is my presence before you today, without any PMOI member accompanying me to be able to keep me by force. If there was any force, wouldn’t I say so at the first moment of this private meeting?

“Moreover, hadn’t US officers and organs conducted repeated private in-person interviews in the past with me and each and every PMOI member?

“Hadn’t they asked us questions about leaving the PMOI and even insisted and encouraged, and at times threatened us to leave?

“Therefore, is it logical that despite such facts it is now claimed once again that there is any force used to keep me here against my will, or any other PMOI member, and being held in this organization and to remain in Ashraf in the past and the present?”

He tried to resort to family relations and emotions, and claim that your father loves you and ... in order to finalize his mission of forcing me to meet with them. I said in response:

“If a father loves his child, why wouldn’t he have any respect for their decision, being to continue this struggle for the freedom of my people and country from the mullahs’ dictatorship? And instead, as supererogation to these criminal mullahs, he has been pressuring and psychologically torturing me for many years now...”

This Iraqi official, who had for the first time seen a tip of the iceberg about the truth regarding the wave of allegations and demonizing campaign against the PMOI, became more and more interested about the explanations and responses I provided about the claims and allegations raised by the Iranian regime, and listened very carefully to my remarks.

His final words were:

“I must admit that they had filled my head with so many lies about you. However, one of the reasons I accepted a responsibility about Camp Ashraf was that I wanted to see the truth for myself. Now I can truly say that I have personally seen the truth.”

### THE IRAN-MALIKI “CIRCUS” AROUND ASHRAF

In February 2009 the mullahs’ regime through the Ministry of Intelligence and its official and front branches inside the country and abroad, in addition to its embassy in Baghdad and the terrorist Quds Force, and through dispatching and repeatedly using its hired MOIS agents, launched a major 24/7 psychological torture fiasco or “circus” at Ashraf’s entrance. **Iranian Resistance draws attention of UN and US to foul plot by Iran regime and Iraqi committee responsible for suppression of Ashraf**

*Dispatch of the third group of families to Ashraf by the mullahs' Ministry of Intelligence*

The Iranian Resistance draws the attention of the United Nations Secretary General, Special Representative of the Secretary General, United Nations Assistance Mission for Iraq (UNAMI), the United States Government and the American forces in Iraq to an extensive conspiracy by the Iranian regime's Ministry of Intelligence and Security (MOIS) against the residents of Camp Ashraf in Iraq.

In a ridiculous and revolting show, the MOIS in coordination with the Iraqi embassy in Tehran on one hand and the Iranian embassy in Baghdad cooperating with the Iraqi committee in charge of suppression of Ashraf residents on the other, dispatch a number of relatives of a few Ashraf residents to Iraq. Mostafa is a known agent of the MOIS and has been sent to Ashraf more than ten times over the recent years to create chaos and crisis. #### **Mission to tape footages for a “family drama” TV production by MOIS “producers” against the PMOI**

Following the failure of the MOIS’ main efforts in their filthy war continuing for many years now by hiring Mostafa Mohammadi and ... and focusing on separating me from the PMOI, taking part in the scandal of dispatched agents and “family members” at Ashraf’s front gate, the main subject of his next missions was to be a main perpetrators of the psychological torture against Ashrafis through blaring 320 loudspeakers.

However, he also pursued another important mission that he was assigned to long ago. He was to tape his tirps to Ashraf, meetings and talks with me and other scenes, including secret taping of US officers stationed in Ashraf involved in this case.

Ever since the MOIS scandal was launched to psychologically torture the residents at Ashraf’s gate, filming these footages became part of Mostafa Mohammadi’s daily mission. He was assigned to film step by step and every scene necessary for a “family drama” TV production that was specially “ordered” for.

This was an effort continued for many years that finalized in TV “documentary” named “An unfinished film for my daughter Somayeh”(!!) produced by unknown and notorious MOIS “artists”(!!) and aired by the Iranian regime’s media outlets. This was a difficult impasse the pretenders in this regard could not flee from and their efforts were completely futile. This scam was so ridiculous that left no room for any individual with minimum wisdom to be fooled. It only raised a series of questions such as if this film – from its beginning to the end, from its broadcasting and advertisement, from all the expenses and personnel involved – has nothing to do with the Iranian regime and MOIS and is just considered to be a



family movie, then why aren't the footages of thousands of families and millions of other Iranians aired as such by the mullahs' media?!

Why are none of those advertised and praised to such an extent by the regime/MOIS media outlets and officials?!

Or why aren't any of them receiving numerous awards from the regime's mullahs and officials?!

And why isn't so much efforts, expenses, discussions, evaluations and trips to Iraq, Canada, Europe and ... conducted for them?!

And why isn't the regime's documentary producers making any documentaries about them?!...

### **Filming footage for family documentary!**

One of Tehran's documentary projects against the PMOI and Ashraf was the production of "family drama" (!) the MOIS planned by using Mostafa Mohammadi and in coordination with state-run TV. By filming footages of Mostafa Mohammadi for a few years, including footages of the necessary scenes taken by the al-Alam TV cameraman, the raw material for a “family drama” was procured, and along with the scenario, was sent for production.

Finally, the fruit of these missions was recently aired on TV and other formal regime outlets after production and adjustment in the mullahs’ “artistic-political-romantic” (!) workshop. It was also widely publicized and advertised, and after a few years of efforts, planning, execution, allocating specific budgets and massive assets for this filthy war and continuous psychological torture, by using a father who has sold himself to the inhumane enemy. The MOIS finally assumed complete responsibility for the production of this TV “documentary” dubbed “An unfinished film for my daughter, Somayeh”, and it being aired through the regime’s state-run TV. The missions of each and every one of those involved, including Mostafa Mohammadi was sealed in coordination with the notorious MOIS.

Therefore, the Iranian regime attempted to cloak its defeat in the main aspects of this battle, being separating me from the PMOI through this despicable puppetry. It ridiculously resorted to its propaganda lies against the PMOI and portraying everything upside down regarding the PMOI’s perseverance and unwillingness to succumb to Tehran’s demands, and repeating the atrocious lie and ridiculous claim of “me being abducted by the PMOI and kept against my will in Ashraf” from its flunkey under the pretext of being a father.

These futile efforts will never fool anyone.

For this very reason, it has been a few months that the Iranian regime and notorious MOIS have been forced to use their propaganda machine to make use of this ridiculous film again. This was especially true during the anniversary of the PMOI’s Operation Eternal Light in August (through channels 1 and 2 – Press TV and ...) and publishing news pieces along with explanations and propaganda clarifications in the regime’s official and unofficial media outlets and chain MOIS websites.

### **Why is the regime resorting to this propaganda and re-airing of this fabricated documentary?**

The mullahs’ crises-stricken regime, despite all its efforts and propaganda investment, is currently witnessing a daily increase in Iranian youth and women becoming interested in the PMOI.

In parallel to intensifying its plots, pressures and crackdown against the PMOI inside Iran to confront even the smallest connection or measure that in any shows a support for the PMOI, against Ashrafis in Liberty and abroad and the international stage, the mullahs are hysterically and astonishingly increasing their scope of demonizing and smear campaign. This is an effort to maybe tarnish the PMOI’s image, and that of its relations between its members, to just maybe control the increasing wave of support for the PMOI. The so-called documentary produced by the MOIS after many years of efforts, planning, mocked scenery and “artwork” (!) in the psychological torture (!) by taking advantage of family relations, using Mostafa

Mohammadi, spending huge amounts of money and production assets in this regard, was just one of the series of countless defensive efforts by the regime and their Gestapo. This was aimed at raising the spirit of its elements in the face of the rising status of its main enemy and only ideological-political-social enemy – being the PMOI.

The PMOI are the role model of perseverance and persistence for the Iranian people, especially the youth and women against this anti-Iranian and inhumane regime.

Explanations and concessions provided by the MOIS in introducing and advertising this document through its experts, that are truly agents involved in this film production and the filthy war and demonizing campaign against the PMOI, speak for themselves.

Morteza Payeshenas, the director of this film, very vividly described the regime's chronic problems in relations to the PMOI and their necessity to make such films aimed at confronting the tendency seen amongst the youth. Below are a few examples in this regard:

**Bibak Website (Iranian regime – 1 July 2014): Interview with Morteza Payeshenas, director of “An unfinished film for my daughter, Somayeh”**

**Question: Why now?** [Why was this documentary produced now?]

**Answer:** The same reason that my generation needs, for us to make films about this organization, is a need seen in the society. The PMOI has not remained silent in the past few years and they are presenting themselves, and with the media tools they have at their disposal they are continuing their work in this regard. The silence that had lasted for years about this organization, with nothing being said about them, was a mistake that they used to advance their work.

This organization, with the media at their disposal, is trying to have an interesting vitrine for the public. They might say nice things, just as they talk about freedom and democracy in their network...

**Question: Why are you so worried about this organization?**

There are many subjects about this organization. In my last piece, “Meeting behind Ashraf's walls”, I raised the issue of the assassinations. Why do I focus my work on the PMOI? Because in my opinion it is the essence and a glimpse at most of the sectarian behavior in this organization and ...

**Channel 1 TV Network (Iranian regime – 1 August 2014):** ... the intelligence of this director [the director of the MOIS documentary] is that just a specific type of people were not focused on. It is very important for us to take into consideration that this documentary is not just about what the PMOI has done; this documentary is about this hypocrite organization, the PMOI, what are they doing, meaning they are recruiting... the case of Mostafa Mohammadi is not just about what has happened. The issue is that families must be careful, from now on they might recruit your youth under the excuse of getting a visa to go abroad looking for work.



**State-run Tasnim news agency (23 July 2014)** – A ceremony was held to pay homage to the producers of the documentary “An unfinished film for my daughter, Somayeh” was held in the Sima Film Center, and the director of this documentary (Morteza Payeshenas) said:

It is necessary to commemorate the father of Somayeh for confessing to this mistakes in such a scope.

**Masoum Zadehan**, director of the Sima Film Center said, ... “The Dideban institute provided cooperation in this production and the Islamic Republic network has aired this documentary in three of its nationwide TV networks...”

**Payeshenas:** We went to six countries for our main subject and to produce this documentary... we had 4 visits to Iraq, with one lasting for 35 days. The director of this film extracted 90 minutes from a collection of 600 taped films...

**[Mullah] Salek**, head of the parliament Culture Commission: “After we surpassed the seditions of 1999 and 2009 in psychological and soft war, today there is a larger sedition triggered with the image of the Monafeqin (*the regime’s derogatory term to describe the PMOI*)...”

In this ceremony Morteza Razagh Karimi, Ahmad Mir A’laie, Hojjat al-Islam Salek and Ma'soum Zadehan were present...

Payeshenas’ remarks about the cinema film festival received no major welcoming:

**State-run Fars news agency (7 August 2014)** – **Morteza Payeshenas:** ... the Resistance Film Festival is a very important subject in the history of our country... this event is very important for our country’s culture... the Resistance Film Festival has not been successful in the international stage... we have only



been able to come in contact with countries that we have a common voice with, such as Syria and Lebanon...



The Iranian regime used a number of its experts and agents as directors, critics and ... to ridiculously claim that Mostafa Mohammadi has nothing to do with the regime and this is a “family” (!) documentary.

On the other hand, despite the emphasis and deceitful remarks made by Morteza Payeshenas trying to portray this state-run documentary as a “personal”(!) and “family”(!) film, his words actually showed the traces of all this clearly going straight up to Khamenei and his Minister of Intelligence.

This entire movie and all those involved, from the very beginning to the end, and all aspects including the scenario to filming, directing and acting, the budget and production, and getting TV channels to air and advertise the film, were all organized and provided for by the MOIS, and carried out by the agents and elements of this notorious ministry or its associated entities inside the mullahs’ regime.

The regime’s director of this documentary said in his interview with the Bibak website (republished in state-run ‘Vatan-e Emruz’ and ‘Mashregh News’) in response to questions:

**Bibak Website (Iranian regime – 1 July 2014):**

**Question: How did the festival react to this film, why was it not welcomed very much in the Fajr festival?**

**Answer:** The film was presented in the political section of the Haghghat Cinema Documentary Festival and received the best film award in this festival. It was in the Fajr Film Festival that the film didn’t receive any awards. You have to accept it that it is a very sensitive subject, despite the fact that I placed all my effort to present a humanitarian issue. However, the entire film was focused on a political issue. Because we are making a documentary film about the PMOI; my guess is that they didn’t see it appropriate to mention this film.

**Question: Despite the fact that you made a political documentary, however, you keep on emphasizing you are not a political figure, why are you not making an official political statement? Are you afraid?**

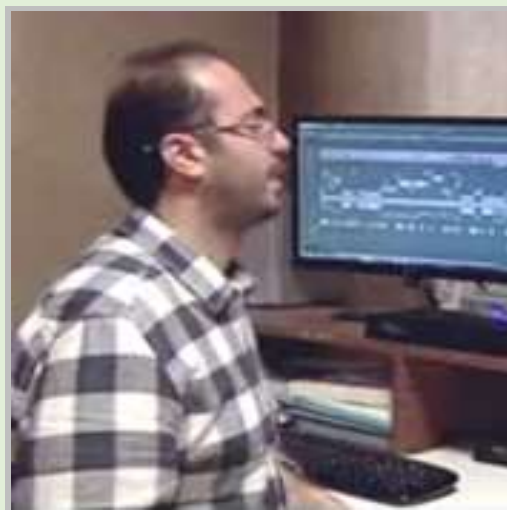
**Payeshenas' answer:** I made my piece in a way to be successful across the globe. The world has problems about our judgement of the [PMOI] and they say our pieces and judgements are lies... **Question: Does the Mohammadi family intend to return to Iran?**

One of the problems that we had in making this film was that Mr. Mohammadi didn't want to be marked like this.

In the very beginning in our contacts when he learned that I lived in Iran and was the representative of the Islamic republic, he was very reluctant. But little by little as we became more and more acquainted, and in fact the film's footages went forward... our cooperation became more serious.

Seeing such a film for our younger generation and the families that have lost loved ones, and it has been years since they have been forced to support the [PMOI], this film changes their opinion.

## CHAPTER 13

### TERRIFIED OF OVERTHROW – DEMONIZING FIASCO

The production, advertisement and repeated airing of the fabricated “documentary” entitled “An unfinished film for my daughter, Somayeh”, coming at a very high cost with an enormous amount of time and energy expended by numerous state organs in Iran, especially for the mock scenes necessary for the “monody” video clip about the tragedy of “my abduction”(!!) from Canada and “being kept against my will”(!!) in Ashraf, depicts just one of the numerous false allegations and inhumane projects led by the mullahs’ regime against the PMOI.

And this takes place despite the fact that based on undeniable evidence – a portion of which was shown in this book – the false nature of these accusations raised against me, as the target of these repulsive lies, were proven by Canadian organs and US commanders and officers stationed in Ashraf following investigations and conducting private in-person interviews with me. Moreover, my free decision to remain with the PMOI sealed this matter. Additionally, international human rights organizations have been informed about the entire background and investigation process of this matter, along with court orders, legal documents and relevant evidence.

This example itself unveils the truth of the political scene in Iran, especially in regard to the confrontation between the PMOI and inhumane mullahs’ regime, including:

- When the regime launches and pursues such a long-lasting and very expensive project about just one PMOI member with so many ridiculous lies, any simple or expertise calculation shows the dimension of the regime’s demonizing campaign against the PMIO as its main enemy.

One needs to only take a look at one of the regime’s projects about Ashraf residents conceded to in a Ministry of Intelligence website.

**Nejat website (MOIS), 13 September 2014:** “From the winter of 2010 to September 2013 more than 10,000 trips have been made by the families of those detained in Ashraf, and these families have gone to Iraq to protest outside the Ashraf detention center.”

This is the same state-run scandal at Ashraf’s gate that is totally fabricated by the MOIS, the terrorist Quds Force and the mullahs’ embassy in Iraq, and was missioned to psychologically torture Ashraf residents with hundreds of loudspeakers for 677 days from February 2010 onward.

The regime’s objective in launching and following this inhumane project against the PMOI was similar to the same objective they sought in repeatedly dispatching Mostafa Mohammadi and torturing me over and over again.

Furthermore, as I mentioned this is just one of the countless projects carried out by the regime, because this regime has never spared any effort in conducting all types of plots against the PMOI; either in torture and psychological warfare, or physical attacks and barbaric killings and massacres, or plots and clandestine deals with various governments and international counterparts, lies, demonizing campaigns and using all possible means and leversages ...

Testimonies and orders issued by government organs and institutions revoking the MOIS claim about my presence in Ashraf, is considered as an evidence for the annulment of the mullahs' other allegations and smear campaigns against the PMOI. The MOIS, by hiring my father – willing to sell his own dignity and family emotions to pursue the MOIS' demands in impelling me to defect from the PMOI and turning to and enemy of the PMOI – was a repetition of the same false allegations. The MOIS had also filed complaints with relevant bodies, especially the Canadian government and Immigration Ministry.

It had even requested from Iraq's judiciary to issue arrest warrants for senior PMOI officials on charges of abducting and holding me against my will in Ashraf.

US commanders in charge of Ashraf's security, along with JIATF commanders were all convinced by the Iranian regime there was no motive other than family emotions and merely a father feeling responsible about the fate of his child.

Considering these pretexts, when the false nature of such allegations are proven, the fate of the other lies and smear campaigns pursued non-stop by the regime against the PMOI becomes crystal clear.

It is worth noting that during these years, the allegation of "me being abducted and kept against my will by the PMOI" was repeated by the MOIS and its agents while I – as the subject of these allegations – have always been prepared and responded firmly, revealing the false nature of such charges.



This took place during a campaign for many years with my direct and active presence in all legal, judicial and political scenes; along with exposing interviews and revelations in the press and TV; by responding in person and in private to relevant organizations; dozens of interviews with reporters, repeating time and again that these allegations were sheer lies. All these efforts received widespread coverage and the public opinion was very much informed about the entire process. In addition to my clear explanations and stances, there is a series of testimonies, court orders and documents provided to government and international organs and institutions officially confirming my free choice and revoking the MOIS' false allegations. However, despite all this evidence – each being enough to set aside the regime's allegations once and for all – we are once again witnessing that through immense obscenity the regime continues to repeat the same lies and produces more “documentaries”, awards those involved, holds various roundtables, interviews and airs propaganda and commentaries in order to attract attentions for its state-run media outlets, and ...

As mentioned before, repeating already-rejected allegations in such manner mirrors the void nature of all other allegations and the regime's entire demonizing campaign against the PMOI, at a time when they were sent to investigative judges and courts in France, the UK, EU and US.

- Despite numerous credible court rulings in Europe and the US in favor of the PMOI, the mullah's regime is more than ever before beating on the drums of revoked allegations and unveiled lies, as it also escalates its lies against the PMOI; since each and every victory gained by the PMOI sounds the alarm for the regime more than ever before, and this is fueled by an undeniable political fact that the PMOI is the main enemy and threat, and the only adversary against the mullahs' regime.

- The demonizing campaign against the PMOI depicts the most dangerous key issues for the regime, especially by focusing on the leadership, organization and their internal ideological revolution (transition), which fostered a generation of PMOI members that until the very last member of this organization is alive, the main issue and objective on the table will remain overthrowing the mullahs' regime.

In other words, the regime's hysterical approach in this regard results exactly from its anti-revolutionary knowledge of the PMOI's secret of resistance and perseverance, the dynamism of growth and progress, and the necessary key behind these advances and obtaining victories.

The mullahs know very well that the PMOI, having such a leadership, organization and internal revolution, will never be defeated by Tehran's plots, crimes and deals; in fact this organization has defeated all such measures and emerged more powerful than ever before, becoming the only antagonist and the main threat before this regime's very existence.

This relationship was the driving force behind the PMOI members' motivation, bravery and willingness to sacrifice their all more than ever before, the report added.

The abovementioned issues were a summary of one part of this report's conclusions, coming from the mullahs' most notorious crackdown entities, at a time when the regime had targeted the PMOI with the most repulsive smear campaign about their internal revolution for three long years.

You now see I am not exaggerating at all in saying the mullahs knows better than anyone else its propaganda and smear campaign against the PMOI are false and completely lopsided. Due to the fact that it understands the PMOI's secret of perseverance, unwillingness to surrender and will to continue their heroic struggle, make more advances and gain more victories against the regime, it has continued to target this organization with its relentless propaganda war machine and most revolting smear campaign.
